AMERICAN REVELS. PHILADELPHIA, Oct. 31.—The press publishes a sworn statement of Jas. E. Anderson, ex-supervisor of East Feliciana parish, made to-day before a notary public of this city respecting the authenticity of the Sherman-Anderson-Weber letter, alleged to have been written by the present Secretary of the Treasury and Anderson and Weber in New Orleans. It sets forth that in June, 1872, after he had testified before the Potter committee on Louisiana affairs he met in Philadelphia E. L. Weber, who in the course of a long interview, stated he was in possession of a letter and would testify in favor of the Democrats before the Potter committee for \$10,000, and that Anderson repeated the conversation to J. R. Snyder, attorney of the city, a personal friend and college classmate of Clarkston N. Potter, and that on the day following Weber, Anderson and Snyder went to Washington. Weber declined to testify for over two weeks, giving as a reason that the Democratic managers who he names would not pay the sum demanded. On the 29th of June, 1878, Weber told Anderson that satisfactory arrangements had been made and that he was ready to testify, which he did on the 23rd of July. Weber then showed Anderson a letter received by him (Anderson) and D. A. Weber from Anderson, as supposed. Anderson then compared the signature with the autograph of Sherman exhibited at Brady's in Washington, and expressed to Weber, doubt of its genuineness. The affidavit goes on to explain the variations in the testimony of E. L. Weber and the efforts made to fasten the letters upon the Secretary. It quotes by name quite a number of outside agents of the Potter committee and members of the National Democratic Committee.

CHICAGO, Nov. 6.—Returns from Illinois as far as heard from indicate Smith, Rep., for State Treasurer, 54,498; Cronkite, Dem., 34,502. Bates, Greenbacker, 14,787.

DETROIT, 12 m. 6.—From present indications the Republicans have elected the entire Congressional delegation from this State in the 1st district. Newbury, Rep., is elected in this district by a plurality of 1,028. The Legislature will be strongly Republican. The 450 votes and precincts heard from give Crosswell a plurality of 24,005.

CHICAGO, Nov. 6.—Returns from the 13th Congressional district make it pretty certain that Tipton, Rep., is defeated by Stevenson, Greenbacker and Democrat, by over 500 majority. Nothing definite is had from the 18th district yet, but both parties claim it. The indications are that the Republicans have a fair working majority in the State legislature, though Democrats do not concede it.

SAVANNAH, Ga., Nov. 6.—Nichols majority in the 1st Congressional district is estimated at 8,500.

JACKSONVILLE, Fla., Nov. 6.—Hull, Dem., is certainly elected in this district and Davison, Dem., in the 1st Congressional district. The legislature is Democratic in both branches.

BOSTON, Nov. 6.—The result of yesterday's vote for Governor in 336 towns foot up, Talbot, 134,108; Butler, 103,321; Abbott, 9,804; Miner, 1,867. Talbot carries every district in the State by a handsome majority except two Boston districts. Eight towns to hear from will carry Talbot's plurality up to 28,000 over Butler. The result in the 6th Congressional district is still in doubt.

TRENTON, N. J., Nov. 6.—The Legislature stands, Senate, 11 Republicans, 10 Democrats. One of the latter is Independent. House, 36 Reps., 24 Dems. Smith, Democrat and Greenbacker, is elected to Congress in the 33rd district by 1,000 majority.

AMERICAN REVELS. PHILADELPHIA, Oct. 31.—The press publishes a sworn statement of Jas. E. Anderson, ex-supervisor of East Feliciana parish, made to-day before a notary public of this city respecting the authenticity of the Sherman-Anderson-Weber letter, alleged to have been written by the present Secretary of the Treasury and Anderson and Weber in New Orleans. It sets forth that in June, 1872, after he had testified before the Potter committee on Louisiana affairs he met in Philadelphia E. L. Weber, who in the course of a long interview, stated he was in possession of a letter and would testify in favor of the Democrats before the Potter committee for \$10,000, and that Anderson repeated the conversation to J. R. Snyder, attorney of the city, a personal friend and college classmate of Clarkston N. Potter, and that on the day following Weber, Anderson and Snyder went to Washington. Weber declined to testify for over two weeks, giving as a reason that the Democratic managers who he names would not pay the sum demanded. On the 29th of June, 1878, Weber told Anderson that satisfactory arrangements had been made and that he was ready to testify, which he did on the 23rd of July. Weber then showed Anderson a letter received by him (Anderson) and D. A. Weber from Anderson, as supposed. Anderson then compared the signature with the autograph of Sherman exhibited at Brady's in Washington, and expressed to Weber, doubt of its genuineness. The affidavit goes on to explain the variations in the testimony of E. L. Weber and the efforts made to fasten the letters upon the Secretary. It quotes by name quite a number of outside agents of the Potter committee and members of the National Democratic Committee.
