Cassius M. Clay, the "Sage of Whitehall," former minister to Russia, and a widely-known Kentuckian, is dead at his home at Whitehall.

Woman Wanted for Murder. Suddenly Vanishes from Denison, Ia., the Day the News Arrived and Cannot Be Found. Denison, Ia., July 27.—The sheriff has not been able to locate Mrs. Ella Hodge, who is wanted in Salt Lake City on a charge of murdering William Ryan, a peddler of that city. She vanished suddenly the day the news arrived, and although every effort has been made to learn her whereabouts

no clue has been secured. Mrs. Hodge is the adopted daughter of a well-to-do couple here. She is a widow 10 years of age, and has a brother in Denison. For some she has been employed by the telephone office, and has avoided questioners who attempted to elicit from her information touching her life in Utah.

Charge Against Foreman Miller. Washington, July 24.—President Barrett, of the local bookbinders' union, has presented to Secretary Corley and Public Printer Palmer affidavits regarding the case of W. A. Miller, the assistant foreman in the government printing office, whose statement was ordered by the president. These affidavits relate to charges of moral unfitness which formed the basis of Miller's expulsion from the union.

Whole Town Wiped Out. Guthrie, O. T., July 23.—The town of Landers, population 900, was wiped out by fire. Loss, \$200,000. Mrs. Jason Burgess was burned to death.

Swafford, injured internally; Fred Lorenz, buckshot in legs; W. Lattern, buckshot in both arms; Harry Renick, of Taplin, Ill., buckshot in left foot and leg; two unknown men, wounded in the arms and hands with buckshot; Henry Slade, of Pavillion Heights, buckshot in left side; two unknown men, one shot in left arm and the other in the hand; unknown young man, wound in head; four unknown negroes, beaten into insensibility by the mob; unknown woman, carried away in a buggy after she was seen to fall; H. Hines, shot in neck; Otto Henke, shot in arm. All the unknown, except the woman, refused to give their names.

Troops Now Guard the Town. Four companies of militia have arrived from Springfield. Companies A, I, B and H, of the Seventh Illinois Infantry, were sent in reply to urgent requests to the state officials. The troops marched to the market house opposite the jail, and the streets were cleared and the threatening attitude of the crowds disappeared.

Conclude Likely To Be Short. The ceremonial of the convolve established by Gregor XV, is to be followed at the coming meeting. The cardinals decided during the convolve to eat in common, in order to facilitate their work. A local paper quotes the response of Cardinal Svanpa to a question as to whether he believed the convolve would be of lengthy duration, as follows: "On the contrary, I think it will be very short. I believe that two days will suffice to reach an agreement."

Italy and the Vatican. Another paper quotes Monsignor Frascina, next in line to the possibility of the election of a pope who would reconcile the Vatican and the Quirinal thus: "No pope ever noted Italy. The government must reconcile itself to the pope. Certainly Italy, on the occasion of the death of Leo, showed herself well disposed for a reconciliation."

CONQUERING HERO COMES. Reception to an Editor Who Had Criticized a Decision of the Missouri Supreme Court. Warrensburg, Mo., July 24.—James Shepherd, editor of the Warrensburg Sentinel, who was fined \$500 by the state supreme court for contempt in printing an article criticizing a decision rendered by that body, was accorded an extraordinary reception when he arrived home from Jefferson City. As soon as it was learned that Editor Shepherd had been fined some of the leading men here telegraphed him to draw on them for the amount.
