

Iowa Idea vs Standpatters.

In an address delivered in Des Moines on the 12th inst. Governor Cummins re-affirmed his position on the tariff; known as the "Iowa Idea," and threw many bombs into the camp of the "Stand Patters."

"We, who advocate reciprocity, believe that many of the duties in the present schedules are too high, and that they should be reduced, not only to save our own people from unjust exactions and excessive prices, but, through reciprocity, to preserve and extend our trade with foreign nations."

Not a Square Deal, by Any Means.

We like President Roosevelt because he averages up better than so many of his predecessors. But this wholesale way of such men as Morton and Loomis is by no means reciprocal to him as a citizen or as the chief executive officer of a great nation.

When the Federal Court issued an injunction against the officers of the Santa Fe Railway, forbidding the granting of rebates, these officers should have obeyed the court's mandate or gone to jail just the same as a Chicago teamster or any other wage earner guilty of a contempt of court.

Ex-Secretary Morton, while vice-president of the Santa Fe System, violated in a wholesale way the injunction issued by the court, and because he was the officer of a wealthy corporation he was allowed to do so with impunity. But when a poor Chicago teamster was found guilty of a single offense he paid the penalty prescribed by statute.

In the estimation of the President the contempt of a laboring man must differ from the contempt of a railway vice-president.

In some respects President Roosevelt could prove it by following the example of President Diaz of Mexico. He makes it his business to see that the law is enforced against rich and poor alike. Anyone who knows anything at all about the President of the Republic of Mexico, would know what would have happened to Morton when his crime became known. It is very safe to say that he would have got a square deal, just the same as any other violator of the laws of his country.
