

Pursuant to the call of the Democratic National Committee a delegate convention of the Democratic party of Iowa is hereby called to meet in the city of Cedar Rapids on Thursday, March 26, 1908, at the hour of 10 o'clock a. m. the purpose of said assembly being to provide representation from this state to the Democratic National Convention to be held at Denver, Colorado, on July 7, 1908, by the election of four delegates and four alternates at large and two delegates and two alternates from each of the eleven congressional districts of the state. Also for the transaction of such other business as the convention may deem necessary and proper.

The ratio of representation will be one delegate from each county and two additional delegates for each 200 votes cast for the Hon. Claude R. Porter for governor at the last general election. Upon such basis the counties will be entitled to the number of delegates as set forth below:

Thomas Jefferson, the founder of the democratic party, believed in the rule of the masses, and favored every measure which tended to broaden local self government. Alexander Hamilton took the opposite view of public affairs.

Bryan Will Not Campaign With Bushwhackers.

Last Friday Bryan spoke at Springfield, Ill., to the State Federation of Bryan Clubs, an organization with an initial roster of seventy-nine clubs. Mr. Bryan said that he would not make another campaign with bushwhackers. He avoided personalities but the following are extracts from his address:

"I want instructed delegates," said Mr. Bryan. "I believe in instructions. I do not care as to the candidate. Whoever he is he should have delegates instructed by the people who elected them. They should represent the wishes of the people."

"If I am to be your candidate I want your delegates instructed for me. If I am your candidate again it will be in answer to a call from the party and upon that condition only am I a candidate. If the voters of the party want me for their candidate they will instruct their delegates to that effect."

"I am perfectly willing to fight all the enemies that can get in front of me, but my enemies shall not get behind me again. I want my enemies in front of me this time and not behind my back."

"Then there is one other thing. If I am nominated and if I am given a platform on which I can stand and fight, I have a right to assume that the party will place the management of the campaign in the hands of men who want to see me elected. I have the right to assume that the committee in charge of the campaign will be willing to devote their time to winning a victory."

"In 1890 I made a campaign with a committee some members of which did not even attend a committee meeting. I shall not make another campaign with bushwhackers."

Hon. James H. Trewin is a candidate for congress in the Cedar Rapids district. Mr. Trewin's Delaware County friends, regardless of party, wish him well on account of "old lang sime."
