THE CHESTER AND OHIO CANAL.--We saw yesterday two letters from upper sections of the canal, written by superintendents of the same. It appears that about one hundred and fifty feet of the solid stone work of the dam, put in in 1837, have been "knocked off," to restore which will require one month's work.

The account stated that Mr. W. was boarding at the Marshall House in Alexandria, and on Saturday last paid a visit to Washington, and on returning to Alexandria discovered that during his visit the metropolitan city he had been robbed of the check. He immediately telegraphed to New York to have payment stopped, and rested satisfied that whoever had the paper it could be of no use, and accordingly caused an advertisement to be inserted, offering a reward of \$50 to whoever would return the lost paper to him at the Marshall House, Alexandria, and proposing to ask no questions about it. Yesterday morning, and before the advertisement had appeared, the check was presented at the banking house of Lewis Johnson & Co., in this city, by Mr. Alexander Dubant, duly endorsed with the name of Mr. Wallace, and was discounted by the Teller, who sent it immediately to New York for collection.

Shortly afterwards, the proprietors of the bank, reading the advertisement, and knowing that for the first time that payment had been stopped, and that something was wrong, information was at once given to Captain Goddard, Chief of Police, who proceeded to Dubant's place of business, (restaurant), and took him into custody. Mr. Dubant protested that the matter was all right as far as he was concerned; that he could prove that the check had been endorsed by Mr. Wallace, but refused to state anything further in relation to the transaction. He was held to bail in the sum of \$2,000 for his appearance before Justice Donn at 4 p. m. to-day to answer further. Mr. James E. Dunawin is his security. Capt. Goddard has telegraphed to Alexandria for Mr. W., to be in Washington to attend the investigation, and here it will appear whether he consents, and if the check or was robbed of it.--Wash. Star.
