DARING ROBBERY.—A daring robbery was perpetrated at an early hour Saturday evening at Rettew's pawn broking establishment, Philadelphia. About 7:30 while the street had its usual crowd of Saturday night shoppers upon it, a man stepped into the vestibule of the main entrance to the office, threw a slip-noose over the door-knob and fastened it to the screen. He then stepped out and threw a brick through the large plate-glass front window, breaking a jagged hole two feet in diameter directly over the most valuable portion of the displayed jewels. Through this break he thrust his arm, made a well-directed grab, and withdrew it on to make a second effort to satisfy his avidity. He then dashed around the corner, leaving the startled spectators staring on at the crash, ran to the proprietor, on hearing the crash, ran to the door, but finding himself unable to open the door got to the side entrance just in time to see the bold thief disappear in the excavations below made for the Reading Terminal. A colored man who witnessed the theft, ran after and caught the robber by the coat, only to be confronted with a revolver and the command, emphasized with an oath, "drop it." He did so, and the thief escaped. The value of the entire haul is estimated at \$1,600, including a pair of diamond earrings worth \$1,200.
