THE COLLAPSE of a Tank. While the main floor of the Adams Dry Goods Company's store, in Sixth avenue between Twenty-first and Twenty-second street, New York, was thronged with shoppers shortly after 5 o'clock yesterday evening in a wooden tank connected with the sprinkler system on the roof, and holding 10,000 gallons of water collapsed. This immense volume of water and a dozen tank staves swept downward through the stained glass covering of the court, a floor below, and descended unhindered in a shower of glass, water, and timbers upon the main floor stories beneath. Ten persons, three of whom were women shoppers who had been standing at the two silk counters, which received the brunt of the collapse, were more or less injured. That some of them were not killed by the heavy staves was considered miraculous.

The panic that followed the bursting of the tank and before the cause of the rush of the water and crashing of glass was known, the thousand or more men, women and young girls on the main floor stood spellbound for a moment. The screams of the standing women, who happened to be standing in the twenty-foot area beneath the skylight, caused all the others to make for the exits on all sides of the building. In the excitement that followed, many shoppers dropped their purses as they ran either for their carriages or for places of safety on the sidewalk. The collapse of the tank set off the automatic fire alarm in the building, and the prompt response of two engine companies and a hook and ladder truck seemed to create greater confusion rather than to allay it. When Supt. Hogan, of the store, saw what had happened, he telephoned the New York Hospital to send all its ambulances. Three responded. The injured were sent to their homes in carriages.

Castillo is now reported to have taken a new base and was reinforced last night by several hundred good fighting men from the steamer Empire City. General Barillas is in the mountains making his way to Quetzaltenango. Barillas has with him a fine body of picked men and is reported to be steadily recruiting his force. No news has been received from Salvador, but the invading force should by this time be well advanced into Guatemala. Resident Guatemalans in Mexico City state that the who's country is ripe for the overthrow of Cabrera. The reason of rains has set in and the roads are bad in Guatemala. Telegraphic communication is difficult, owing to the cutting of wires on the Guatemalan side. Messengers on horseback will be dispatched from Ocoz, where Major Castillo has his forces, and from the flying column of General Barillas, who is pushing on to Quetzaltenango, a city of 40,000 inhabitants. That city is likely to be occupied by General Barillas today or tomorrow. He is immensely popular in that region. The revolution is said to be the most widely spread of any in the history of Guatemala. Foreign planters have been waiting for months for General Barillas to act. OFFICIAL. License Law for 1906-07. An Ordinance for Licensing and Collecting Licenses within the City of Alexandria, for the Year commencing on the 1st day of June, 1906, and ending on the 31st day of May, 1907. Be it Ordained by the City Council of Alexandria, That there shall be levied upon and collected from every person required to be licensed, subject to a license tax, the following taxes, viz: 1. On every license to sell ardent spirits or wines at wholesale, there shall be levied a tax of \$10.00. This applies to persons selling in quantities of five gallons or more. [Note.—Any person desiring to carry on the business of a wholesale dealer and also that of a retail liquor merchant, shall obtain a separate license for each, but his retail license shall only be one-half of that required by section four here.] 2. On every license to every brewer or wholesale dealer in malt liquors, twenty-five dollars. 3. On every license to sell wines ardent spirits or malt liquors, or any mixture thereof at retail, one hundred dollars. (A license to sell liquors at retail shall include the privilege to sell in quantities not exceeding five gallons any one time to any individual, but the license shall not be used to sell, retail, this shall include the privilege to sell, jug or demijohn or other vessels and also the privilege to be drunk where sold.) 4. On every ordinary person or firm selling ordinary retail, the right to keep open a retail store, the license shall be one hundred and twenty dollars. 5. On every commission merchant or firm the specific license or tax shall be twenty dollars. 6. On every person for the privilege of peddling or bartering, the tax shall be twenty dollars per year or three dollars per month, and only the person named therein shall be privileged to peddle under this license. 7. On every person or persons selling or peddling from a peddler's wagon, shall pay a specific license of five dollars for each and every such wagon or wagoner. 8. On every person or persons conducting the business of real estate agent or broker, there shall be levied a specific tax of fifty dollars. 9. On every person or persons selling, or peddling, or otherwise, any kind of goods, wares, or articles, the license shall be one dollar for each and every such article or article of merchandise. 10. On every person canvassing for subscribers to any book or map, or print or picture, or for any other article, the license shall be one dollar. 11. On all agents for the sale of manufactured articles, sold by them on commission, or otherwise, five cents. 12. On every junk dealer, seventy-five cents. 13. On every person canvassing or buying any junk or any other matter for any junk dealer, or for sale to any junk dealer doing business in this city, fifteen dollars, and only one person can canvass under this license. 14. On every person or persons selling antique, or second hand furniture, fifteen dollars; provided such person or persons do not tax or receive some other section of this law or is charged with a tax on capital stock or shares in quantities not less than one box, except manufacturers, fifty dollars. 15. On every ship broker, thirty dollars. 16. On every money broker, or firm of brokers or bankers, having an office within the city, two hundred and fifty dollars. 17. On every person or persons selling or peddling, or otherwise, any kind of goods, wares, or articles, the license shall be one dollar for each and every such article or article of merchandise. 18. On every rectifier of distilled spirits or wines by any process, eight fifty dollars. 19. On every commercial broker, as defined in the revenue laws of the State, there shall be levied a license tax of fifty dollars, and only one person can be licensed under this license. 20. On every proprietor of a bucket shop or dealer in put, calls or futures on oil, or flour, grain, cotton, pork, lard or oil, one hundred and fifty dollars. 21. On every person or persons acting as a soliciting agent for any fire, marine, life or other insurance company, or companies, having an office in the city of Alexandria, fifty dollars on each company represented by such agent, and for each assistant or soliciting agent ten dollars. 22. On every person or persons acting as a soliciting agent for or collecting for any company, or for any other company, in the city of Alexandria, fifty dollars for each company so represented. 23. On every person or persons acting as a solicitor or agent for a life insurance company, or surety bond, there shall be levied a license tax of ten dollars for each company represented. 24. On every house of private entertainment the license tax shall be five dollars, and five per cent on the rental value in excess of ten dollars. 25. On every cook shop or eating house, the tax shall be five dollars. 26. On every person or persons keeping a bowling alley, or saloon, the specific license tax shall be ten dollars, and five dollars on each day of the month. 27. On every person or firm keeping a billiard table or pool table for public use, whether a charge be made for playing or not, five dollars on each table. 28. On every theatrical performance, or any performance similar thereto, panorama, or any public performance or exhibition of any kind, lecture, literary readings and educational purposes, in any hall or public room or other building, where an admission fee is charged, for each week of performance of six consecutive days, five dollars; if less than one week, one dollar for each performance. 29. On every exhibition of a circus or menagerie or other of them, one hundred dollars for each day's performance, and for every show or exhibition connected therewith, or for every day, five dollars for each day's performance. On every exhibition or show where gifts or prizes are distributed or promised, ten dollars for the first day's performance, and five dollars for each additional day, provided said performance is given with a view to the exhibition of skill, whether on a canvas or not, which has a seating capacity of less than fifteen hundred, forty dollars; if over fifteen hundred and less than three thousand, sixty dollars; if over three thousand, ninety dollars. 30. On every attorney at law, physician or dentist, whose practice does not exceed \$1,000 per annum, fifteen dollars; on those whose practice is in excess of \$1,000 and less than \$2,000, twenty dollars; and on those whose practice is more than \$2,000, twenty-five dollars. 33. On every owner or keeper of a daguerrean, photograph or sun picture gallery, or any other picture doing business in this city, fifteen dollars. 34. On every person canvassing for the purpose of enlarging photographs, or sun pictures, or for making crayons, photographs, paintings or other pictures, ten dollars for each day of the month. 35. On every person or firm selling or offering to sell, or otherwise, any kind of goods, wares, or articles, the license shall be one dollar for each and every such article or article of merchandise, whether a charge be made for playing or not, five dollars on each table. 36. On every person or persons acting as a solicitor or agent for a life insurance company, or surety bond, there shall be levied a license tax of ten dollars for each company represented. 37. On every person canvassing for the purpose of enlarging photographs, or sun pictures, or for making crayons, photographs, paintings or other pictures, ten dollars for each day of the month. 48.
