MAYNARD-YOUNG CONTEST.

In Saturday's investigation in Norfolk, of the Second district congressional primary election, counsel for "the people" won a victory in securing permission to count the number of times the word "voter" appears opposite the names of persons on the registration books in the primary in Norfolk city.

The word "voter" was supposed to show who had paid their poll taxes, but counsel for Mr. Young said that the only conclusive proof as to the poll tax payment is the official capita payment list itself.

Secretary Poulson was ordered to produce the books by noon today. The work of collecting evidence will be continued throughout Sunday because of the short time before the beginning of testimony on Tuesday when Mr. Young is to file his answer to charges already brought and new charges in precincts where large majorities were returned for Mr. Young.

While there was no formal meeting of the committee conducting the investigation of the Young-Maynard congressional primary, the attorneys and others involved in it lost not a minute, and evidences of fraud and corruption in connection with the election were dug up in plenty.

It was found by the attorneys for the people who looked into the election in the Fifth ward of Portsmouth that there were 42 more ballots in the box than there were voters to put them there.

NEWS OF THE DAY.

One hundred cases of cholera are reported in Naples, Italy, and 22 deaths.

Both Mr. Roosevelt and the regulars claim victory in the New York republican convention in Saratoga this week.

George Chavez, the Peruvian aviator, the first to fly over the Alps, who was seriously injured, is in an improved condition. The Italian Aviation Society is raising a purse of \$10,000 for him.

John E. Redmond and other prominent Irishmen arrived in New York yesterday and will make a tour in the United States.

It is reported that Philander C. Knox, jr., is in Nevada for the purpose of securing a divorce from his young wife, with whom he eloped a year ago.

The Paris Temps attributes the disquietude in England and Japan on the part of the United States to fortify the Panama canal to fears as to the real purpose of the American government.

The National Egyptian Congress adopted a resolution Saturday, declaring that English occupation of Egypt was illegal, and demanding immediate evacuation and restoration of the constitution of 1881.

It is rumored in Boston that from \$1,000,000 to \$10,000,000 would change hands in the settlement of the shoe machinery war; the settlement was not confirmed, however.

Starting on the second floor from an unknown cause, fire destroyed the big barn at Mayor Gaynor's country home, Deepwells, near St. James, L. I., yesterday afternoon, causing damage estimated at \$10,000.

After deliberating until 11:30 o'clock Saturday night in Baltimore, the jury in the case of William F. Downs, indicted for embezzlement, told Judge Duffy that they could not agree. Judge Duffy demanded that they bring in a verdict and the jury was locked up for the night.

Bobby Leach, of Niagara Falls, Ontario, Saturday afternoon made a trip through the Whirlpool rapids in a barrel, starting from the old Maid of the Mist landing, near the cantilever bridge. Except for a few scratches and bruises, Leach, who claims to have made the trip several times before, was unhurt.

All Masonic records for a gathering of a religious character were shattered yesterday afternoon in Washington when 3,500 Masons assembled in Cathedral Close at Mount St. Alban for the opening of the year.

The attempt on the part of the tongmen of St. Mary's and Calvert counties, Md., to prohibit dredging of oysters inside of a direct line from Cove Point, in Calvert county, to Cedar Point in St. Mary's county, on the plea that to that line extend the waters of the Patuxent river, failed of its purpose.

The Circuit Court at Leonardtown Saturday declared William J. Edwards, of Calvert county, who was arrested and fined \$50 and cost for dredging in the disputed territory, and who subsequently appealed his case not guilty, so that the line established by the present commander of the oyster navy, T. C. B. Howard, from Hog Island, in St. Mary's county, to Drum Point, is to continue to be the line defining the mouth of the Patuxent river.

Five short weeks of connubial felicity came to an end when George Hamilton was placed in jail on a charge of no-support, made by his bride. The couple resided in the fashionable East End, Pittsburg, and Hamilton had a lucrative place with the Pennsylvania Railroad there. His wife said that he was "indolent and too fond of loafing."

While deftly rolling a cigarette before being assigned to a cell, and totally oblivious of his weeping bride, Hamilton said that he preferred jail to "a block of ice," referring to his wife. He appeared happy when he learned he could smoke in prison.
