

UNEARTH TOMBSTONE KILLED AT NOKEVILLE DROWNS OFF THE POINT

Restoration of Sarcophagus of Famous Actress Reveals Interesting Story

When the large stone slab on the sarcophagus of Mrs. Anne Warren, in Christ Church yard, was removed a few days ago to be conveyed to Chauncey and Sons' marble yard, where it will be relettered, the mystery of the disappearance of six marble pillars that formerly were a part of the nearby tomb of Jacob Resler was solved. The six pillars, all of them broken, but not it is believed beyond repair, were found within the Warren sarcophagus, where they were doubtless placed by vandals during the civil war. For many years the stone slab that recorded the fact that Jacob Resler died on October 10, 1805, aged 17 years and 11 months, has reposed a few inches above the ground on the brick foundation that formerly supported the pillars now recovered.

The restoration of Mrs. Warren's tomb is due in a large measure to the efforts of Mrs. Robert C. Powell and Miss Katherine Griffith Uhler, members of the committee in charge of Christ Church yard. Funds for the work have been furnished by Douglas Benson, of Erie, Pa., a grandson of Mrs. Warren. Mr. Benson visited Christ Church during the last G. A. R. conclave in Washington and asked to be shown the tomb. His attention was called to the fact that the elements had entirely effaced the epitaph, and he is now fulfilling a promise made at that time that it should be restored.

The following is said to have been copied from the tomb about 30 years ago, when the letters could be deciphered with a fair degree of certainty:

Beneath this stone are deposited the remains of MRS. ANNE WARREN Daughter of John Burrington, of England, and wife of William Warren, esq., one of the managers of the Philadelphia and Baltimore Theaters

By her loss the American stage has been deprived of one of its brightest ornaments. The unequalled excellence of her theatrical talents was only surpassed by the many virtues and accomplishments which adorned her private life. In her were combined the affectionate wife, the tender mother and the sincere friend. Died in Alexandria, the 28th day of June, 1808.

Since this copy is said to have been made and published without question as to its accuracy, a writer on the subject has come forward with an epitaph of Mrs. Warren which differs in several respects. The later writer puts the name of "John Burrington, esq." in the place of John Burrington; says Mrs. Warren "contained" instead of "combined" several of the virtues attributed to her, and adds that she was 39 years old, though stating in his sketch that she was born in 1773. Mrs. Warren was one of the most eminent English actresses of her period. She died at Radsby tavern, this city, following the birth of a child. It is understood that the two women in charge of the restoration of the tomb will endeavor to clear up the differences mentioned in the two epitaphs before they allow the work to proceed.

D. M. Kite, Former Resident of Alexandria, Victim of Frightful Accident

Struck by a speeding train, D. Millard Kite, of 1761 Columbia road, Washington was instantly killed at Nokesville, Va., 40 miles south of Alexandria, Saturday afternoon. Mr. Kite, employed as a traveling salesman by a Baltimore drug firm, was at the Nokesville Station waiting for a Southern train to take him home. His train followed the Florida special which killed him, Misjudging the distance of the flyer, he started to cross the tracks in front of the station.

The half-dozen passenger loungers in the little depot saw him falter and attempt to turn back as the train bore down on him. The brakes grinding as Engineer J. J. Goodwin attempted to halt the special, they saw him struck and his body tossed fifty feet. Life was extinct when Engineer Goodwin, Fireman Mason Marshall and passengers ran back. The accident happened about 1 o'clock. The body was brought to this city.

Funeral services were held in Christ Episcopal Church, this city, at noon today. Besides his wife, and three daughters, with whom he resided he is survived by two brothers, John Kite, of Somerset, Va., and Surg. I. W. Kite, U. S. N.

Up to a short time ago Mr. Kite resided on south Pitt street in Alexandria. He was at that time a traveling salesman for E. S. Leadbeater and Sons, druggists.

Young Washingtonian Falls From Motor Boat Into River Yesterday Afternoon

About six o'clock yesterday afternoon a motor boat with a party of excursionists aboard was proceeding up the river opposite Notley Hall, on the other side of the river, when it was seen to stop. People of this city who were on the river front at the time supposed the engine had become deranged, and paid no particular attention to the incident until they saw that other boats which were close by at the time were rushing to the scene which had come to a standstill. It was also seen that the boats which had come up were encircling the other, as though something more serious than a breakdown had occurred. Later the boat which had first attracted attention proceeded to this port and upon stopping near the foot of King Street the occupants requested Alderman Brill to open his place of business and allow them the use of his telephone, as one of the party who had left Washington in the morning on the motorboat had fallen overboard while opposite Jones's Point and been drowned. After the relatives of the drowned man had been notified and the District of Columbia authorities had been requested to send the harbor boat down for the purpose of rescuing the body of the unfortunate man the particulars of the accident were learned.

James A. Sullivan, familiarly known to Washington newspapermen as "Jimmie," a member of the staff of photographers of the Washington Star and who had a number of friends and acquaintances in Alexandria, was the unfortunate man. Sullivan fell overboard from a small pleasure power launch known as the Foam, in which he and a party of friends had been to Marshall Hall.

The Foam was heading for the city with Sullivan steering. When opposite Jones Point light it passed a number of pleasure boats near the edge of the channel and Sullivan rose in the stern of his craft to wave his hand to some friends in passing boats. Suddenly he was seen to lose his balance and fall into the water. He apparently made an effort to swim but before his friends in the Foam and the occupants of other boats who had witnessed the accident could reach the spot before he sank from sight.

Accompanying young Sullivan in the Foam were Franklin Harvey, John Winston, and William Wright, all young men of Washington. The instant Sullivan went overboard Harvey threw him a life-line, the boat was quickly turned around, and every effort made to rescue the drowning man, Harvey plunged into the river in an effort to save his friend, when he discovered that Sullivan could not swim.

Close to the scene of the accident were three other pleasure boats, among them the Bohemian, with Frank Roache, Frank Hardie, W. Lohmeyer, Thomas Thornton and L. S. Hart aboard. Hardie dived into the river in an effort to rescue Sullivan after he had fastened a boat hook into Sullivan's clothing, the hold breaking and the body sinking. But after diving several times and failing to locate the body he returned to his boat. The other boats nearby, the crews of which made every effort to rescue the drowning man, were the Elmer B. and the Lorayne. Claude Dumbhardt, aboard the Lorayne, also tried to fasten a boat hook into Sullivan's clothing, but failed to reach it.

Sullivan, who was 26 years old was the son of Mr. Mary Hartford, 512 G. street northeast, Washington. He was married about eight months ago to Miss Gertrude Elizabeth Smith of Washington. The deceased was a member of Hope Lodge, No. 20 A. F. and A. M., of this city.

The body was recovered this morning and taken to Washington.

DEATH OF H. T. NORRIS

Harold T. Norris, 38 years old, for many years an employe of the Paf Shoe Company, died this morning at 7:50 o'clock at his home, 519 Queen street, after a long illness. He is survived by his wife and three daughters, his mother, Mrs. J. E. Norris, three brothers, George A. Norris, Charles Norris and Rudolph L.
