**NOTICE OF STOCKHOLDERS MEETING TO THE STOCKHOLDERS OF WILLIAMS BELMONT & CO., INC.**

A stockholders meeting of the Williams Belmont & Co., Inc., will be held at the principal office of the company in the City of Alexandria, Virginia, at 128 South Fairfax Street, on the 4th day of November, 1920, at ten o'clock A. M. to take action on the question of amending the Certificate of Incorporation by adding thereto the following paragraph as Paragraph VIII.

"The Board of Directors shall be classified with respect to the time for which they shall severally serve, by dividing them into five classes, each consisting of one fifth of the whole number of the Board of Directors. At the first annual meeting held after this amendment has become effective the directors of the first class shall be elected for a term of one year, the directors of the second class shall be elected for a term of two years, the directors of the third class shall be elected for a term of three years, the directors of the fourth class shall be elected for a term of four years, and the directors of the fifth class shall be elected for a term of five years. At each annual election thereafter the successor or successors of the class of directors whose term of office shall expire in that year shall be elected to hold office for a term of five years, so that the term of office of one class of directors shall expire in each year. The total number of directors shall be provided for by proper bylaw of the company."

And upon an amendment to Section I, Article II of the bylaws so that the same shall read as follows:

Section 1. "The business, property and affairs of the company shall be managed and controlled by the Board of Directors. There shall be five directors divided into classes as provided by the Certificate of Incorporation. Such Directors shall be elected as provided by said certificate of Incorporation, and after the annual meeting to be held in 1921 for terms of five years each, and until their successors shall have been duly chosen. Directors need not be stockholders."

And upon such further business as may properly come before the meeting.
