THE WORLD'S DOINGS.

At New Port, Pa., August 7, W. K. Miller, of Harrisburg, was shot dead by Samuel E. Albright, of Montgomery's Ferry. Both were paying attention to the same young woman and met at the same place.

WATER SPOUT. The water spout which last week swept through Bucktonk Canada caused the death of two women and a child, and the serious injuries of a number of persons. Eighty houses were leveled and stock killed and scattered. Loss estimated at \$100,000.

KILLED BY LIGHTNING. On the morning of August 8, Samuel Gray, aged 70, a resident of Grant, West Va. was found dead lying beside a tree that had been struck by lightning on Tuesday. He was making a fire in the place, and had stepped under the tree for shelter. He leaves a family of four children.

BATTLE OF CHICKAMAUGA. A board of officers, consisting of Lieut. Gen. P. H. Sheridan, Brig. Gen. Crook and Col. J. M. Smith, has been ordered to convene in Chicago for the purpose of examining and correcting differences of opinion relative to the actual position and movements of the troops engaged in the battle of Chickamauga.

NEW RAILROAD. Charles L. Colby, F. N. Finney, Joseph L. Cady, Matt Wadleigh and E. H. Abbott, connected with the Wisconsin Central, have filed articles of association in the Secretary of State's office for a railroad from Portage City to Freeport, Ill. and one from Madison, Wis., to St. Paul. The former one million dollars and the latter one million dollars are the estimated cost of the Wisconsin Central.

A PRIZE FIGHT. Owen Malone and John Laferty, the two principals in the recent fight at Turlock, near Pittsburg, Pa., were arrested August 11, for violating the new act of the Legislature against prize fighting and jailed in default of \$1,000 bail. The men did not anticipate such action on the part of the law, as they claimed this action was a prize fight and a violation. They fought for money and were both badly used up.

ENCOUNTER WITH HORSE THIEVES. The Sheriff of Palmito county Texas and a posse had a fight lately with the Texas gang of horse thieves. Larkin Jones was killed, John Jones was wounded and old Jones and two other thieves captured. Jack Morris was left to guard the wounded Jones and assisted the latter to escape. Morris was arrested. Five mares were overpowered the four guards of Palmito county. The horses were taken under to burn the jail, and shot Morris dead in the cell.

QUARTANTINE. A St. Louis, telegram of August 7, says the board of health adopted an order that no steamship that shall have landed at Port Memphis subsequent to the first of August, shall be allowed to land at the wharf, in this city, or discharge freight or passengers within the limits of St. Louis without a permit from the health commission. The order was issued by Wm. J. Knott, of Pittsburg, a steamboat man for many years, protested against this action and proposed a quarantine of freight of ten days during which vessels and cargoes should be thoroughly fumigated, but the board declined to rescind the order.

TERRIFIC EXPLOSION. A Pittsburgh telegram, of Aug. 9, says: A terrific explosion took place this evening on the steamboat Iron Valley upon bound opposite New Cumberland W. Va., 75 miles below here. A second explosion occurred immediately after the first, and the vessel was forced to a great distance in all directions, destroying the entire forward part of the boat, including the pilot house. The pilot, Wise, and the captain's son, Thomas Prince, and a Mr. Prosser, of New Cumberland, were killed. The cause of the explosion is unknown. The engineer claims to have had sufficient water in the boilers.

THE INDIANS. A Fort Peck, Montana Territory, telegram of August 8, says: General Miles has arrived, having driven from the mouth of the Missouri to the headwaters of the Missouri and the Wood mountains. He has divided his force into two bodies, for the purpose of watching the border country all across that Miles' command is entirely inadequate for a force with the savages, which are massed and well armed. Major Walsh visited Gen. Miles, bringing Long Dog, a renegade, blood thirsty chief, who protested that his warriors should not again cross the line to hunt with the savages, and by law was adopted as a peace officer. He is to be permitted for observing Indians to hunt on this side.

MINNESOTA WHEAT BUYERS. The first annual convention of the Minnesota wheat buyers convention was held in St. Paul, Tuesday August 5. There were about 20 members present from different parts of the state. A constitution and by-laws were adopted, declaring its objects to be the promotion and protection of the interests of producers, dealers in and stores of grain, and the dissemination of correct information in relation to the grain trade of the state. Mr. Van Duzen, of Rochester, was elected President, and J. Q. Adams of St. Paul, Secretary and Treasurer. An executive committee was elected: J. C. Boyden, E. B. Andrews, F. M. Thornton, and C. H. Graves.

MURDER OF A MAIL CONTRACTOR. Advice from Chehsta, Kansas, of August 11, says that Captain John Secret, mail contractor on the route west from Vinita, Indian Territory, was found one 100 miles west of Vinita a day or two ago, murdered. He left Vinita a few days ago, on a consignment of mail for the purpose of paying off his mail carriers. It is supposed the desperado who robbed Caryville a short time ago are the parties who committed the crime. As the United States district court, which has jurisdiction over the Territory, is now powerless, owing to the lack of appropriations by Congress to meet the expenses of marshals, it is thought these acts are but the beginning of a reign of crime and lawlessness in the Territory.

SCANDAL IN HIGH LIFE. The particulars of the decidedly spicy encounter which took place at Narragansett Pier Friday evening, in which figure prominently ex-Gov. William Sprague of Rhode Island and Senator Charles F. Johnson of New York, besides one or two persons of less reputation, are as follows: It seems that Mrs. Sprague, who it will be remembered was Kate Chase, arrived at the Pier from Washington a fortnight ago and was stopping at her husband's residence. The former's coachman who she brought with her to instruct her children, Prof. George Luck of New York, by some means excited the Senator's most violent wrath, and he was forbidden the premises. Luck not realizing that Sprague was in earnest visited the house on Friday and the result was a very disagreeable encounter. Sprague came to the house, and finding the professor there, flew into a rage and ordered him to leave; and, seizing a knife, hurled it at the professor's head. Sprague had previously informed one of the guests that he had better leave, as the ladies were to be murdered in the house. The ladies screamed, and a good deal of excitement resulted, during which the luckless literature scolded. Sprague followed him to the vil-
