Report of the Secretary of State. The annual report of the Secretary of State for the year 1876, has been filed with the Governor.

During the year there have been granted charters to 326 corporations, with an aggregate capital stock of \$37,740,000.

The report contains a Brief History of the Territory West of the River Ohio, and a list of the counties of which the following is a brief synopsis.

Virginia acquired title to the Great Northwest by its several charters, granted by James I., the first date being April 10, 1606, May 23, 1609, and March 12, 1611.

The first attempt to exercise authority over the Territory in 1763, was made by the Virginia Legislature, which passed an act authorizing the Virginia Delegates in Congress to petition the United States for the Territory.

In 1783 the General Assembly of Virginia passed an act authorizing the Secretary of State to petition the United States for the Territory.
