BACKWARD, TURN BACKWARD.

We have in Woodstock a fine illustration of the result of telegraph and railroad legislation by congress and railroad management by the Southern Railroad.

At Woodstock, one of the most important railroad stations on the Valley branch of the Southern Railway, the railway and telegraph offices are closed for the transaction of business at 7 p. m. each day. Notwithstanding the fact that the passenger train is scheduled to pass Woodstock at 8.32 p. m. and is frequently later, a passenger cannot purchase a ticket after 7 p. m. If the train should be five or six hours late, he can not get the information, as the telegraph office is closed at seven. It is readi seen how much inconvenience the traveling public is to be put to, in order to comply with the law and save the Railroad Company a few dollars. In this matter, the Railroad company is evidently to be blamed. Another cause of the friction is that a number of legislators who know very little more about running a railroad than a mule does about the intricacies of the tariff, undertake to enact laws for the government of all railroads without regard to the peculiar circumstances of the several roads. Such legislation may read well and please the masses, but when put into practice cause great inconvenience to both railroad men telegraph operators and the traveling public.

Every man should be left free to make contracts as his interests demand. If he is to be hampered with laws, which undertake to take charge of the interests of one or both of the contracting parties, the result will be that both parties will be subjected to inconvenience and loss. Less legislation and more common business sense will help all parties.

A meeting, in the interest of education, will be held in the Court House, Woodstock, on Wednesday, the 25th instant.

State Superintendent of Schools J. D. Eggleston and Examiner Chas. G. Magphis will both be present and it is likely other distinguished educators will be with us. Two sessions, morning and afternoon will be held, and the entire day will be given to an effort to promote more general interest.

Every phase of the question will be discussed but especially emphasis will be laid on the consolidation of schools. It is desired that all who can, will attend the meetings, especially, the trustees, patrons, and persons who are interested in schools.

If there is anyone opposed to the free schools that individual is given an especial invitation to the meeting. We want to work up a great interest in the schools and for that reason it is very much desired that every one should hear the speakers.
