
That's What we Say.

Here is the letter:

New York, July 31, 1895.
EDITOR GAZETTE, Hutchinson, Kas.
Dear Sir:—Enclosed herewith is a sample of one of our six column Southern edition Broadides. Should you desire to use them as sound currency supplements to your newspaper, we offer to deliver at your office, free of all charges, as often as once every two weeks, as many five-six or seven-column Broadides as you may need to cover your subscription list. These will be printed on one side only or on two sides—with miscellaneous matter one page—with "Supplement to the (name of paper and place of publication)" and, when required by local postal officials.

We also offer similar but different matter in plate form. This we supply regularly every two weeks through the American Press Association free of all except express charges from the nearest branch office of the A. P. A. These charges seldom exceed 25 cents per page. Each page contains at least one double and two single-column cartoons. We believe that plate matter is cheaper and better adapted for use in newspapers of more than 1,000 circulation, and that Broadides are better adapted to newspapers of smaller circulation. The cost of supplying Broadides to newspapers of large circulation is so great that we refuse, in most cases, to supply them to newspapers of more than about 2,500 circulation—this is in order to enable us to offer to supply supplements to smaller newspapers.

Enclosed find order blanks, one of which you will please fill out and return to us, should you decide to use either Broadides or plates—we cannot supply both to the same newspaper. Our object in issuing this matter is to counteract the fiat money and the 16 to 1 fiat coinage sentiment that is injuring the credit of our nation and driving away the capital which should develop every part of our country and keep interest low. This committee proposes to do what it can to avert the industrial stagnation thus threatened. The encouragement which it is receiving from all parts of this country, leaves no doubt as to the final result. Hoping that you will co-operate with us in your locality, I am,


