The following is written by Mr. Freeman Bell, who is waiting here for the opening of the Cheyenne country. Mr. F. Bell and his brother, E. W. Bell, are principal authors of the plan outlined below, and at one time they formed a propoganda with Governor David Butler, of Nebraska, at its head, and without means or publishing facilities they commenced the work of organizing. As a result of that work, about 1,000 members were enrolled and many friends to the plan were secured. Among these may be named such men as Senator Peffer, Colonel Harper, Capt. Trevelick and many others. As the propoganda could not make up the deficit in the receipts from their own scanty means the work of organizing was suspended until a reorganization can be effected under more favorable auspices.

By the terms of the constitution the authors and founders are to constitute the National Union for a specified time, and when a few good men will associate themselves in the work and furnish sufficient means, influence and publishing facilities to justify the attempt the work of organization will be resumed.

The law making power of this country and of the world, is largely in the hands of the rich, who are ever ready to besiege congress and the state legislatures for special privileges. Some efficient organization is required to overthrow this power, and to restate the people in possession of their government. It should be remembered, however, that the force of such organization may depend more upon the nature of its constitution than upon the number or the power of its following. An indispensable requisite to efficiency in a united body is obedience on the part of its members. As an example of this, an army, which acts from a common authority, is a more potent organization than a mob that acts only from a common impulse. Though it be true that no civil organization will submit to army authority, yet all Americans should be willing to submit to the authority of the people. What we want then, is a means whereby decisions of authority may be formed for our guidance, and to have this authority "of the people." The Union supplies these wants by its system of reports, and by giving to each member an equal opportunity to say what its decisions shall be.

All the local unions in this organization form one deliberative body, separated only by distance but acting together by system. A matter of even greater importance than this unity of consideration still inheres in the fact that upon important measures they form one voting body. The votes are all counted, and if a national measure is carried by these local unions it must be passed by congress and signed by the President of the United States.

We will suppose that Mr. Blank, a member of the house of representatives, neglects or refuses to act well his part in carrying such a measure through congress. In such a case, an order for concerted action, something like this will come before all the local unions in his district: Has Mr. Blank been untrue to the will of the People's Union in regard to the designated measure, and for that reason shall we forever oppose his reelection to any office of honor or trust in the gift of the people?

As all members of the union are pledged to abide by its decisions, it will be seen that no man who values either his reputation as a representative of the people, or his chances for reelection, or who has any wish to deserve the respect of his countrymen can view such action against him with composure.

It must readily be admitted that the union can wield a sufficient cogent power to command that its expression of the will of the people be formulated into law, and this means that the potency which now inheres in corporations, and without which their power is nothing, may be transferred to the people by organization.

By concerting action as provided for by the Union's constitution, the people can meet at their school houses and other places of public resort and have as much voice in deciding any public measure as they can in deciding who shall be president at our quadrennial elections.

Our people must study public measures and the relations which they bear to the public welfare. This study and this only gives that kind of knowledge which is indispensable even to our safety. Practical political education does not and cannot enter into the curriculum of our public schools. Our ignorance and lack of unity in the past has utterly demoralized us as a united political body, and has left an open door for the incoming of a system which puts half the avails of our labor into the hands of capitalists without compensation. Our newspapers have been the most available source of information to the masses, though they were largely in the pay of cliques and corporations to employ sophistry instead of argument and to give a false coloring to important facts. The reports of the union, district, state and national, will be treasuries of reliable facts and figures upon important public measures, and each local union will

be a school whereby each member may learn the relation which the laws of the land bear to the welfare of the citizen. Let it be remembered when the above is read that the majority will of the people, when properly directed, can have many other beneficial effects than upon national law. I have omitted all reference to the Union as a commercial agency, or to its influence upon state legislatures. We will get a full conception of its benefits only from its practical workings.

We should not distrust the people, or fear to clothe them with power. The masses, with their interest for the common good, are more trustworthy even in their ignorance than our professional politicians, influenced and controlled as they are by the money of the united corporations.

By obligating ourselves to abide by the Union we simply pledge ourselves to abide by popular government with the corporate and moneyed classes left out. All who have had enough of government by the moneyed classes and for the moneyed classes should enroll in the Union, which is a government within our government by the people and for the people.

Section 3 of art. 3 of the constitution reads as follows: "Each local union shall be entitled to its due proportion of power in the suggestion of measures for unity of consideration and action." In keeping with this grant of power the following rules for local unions are adopted for the forming and revision of calendar:

HOW THE UNION EDUCATES.

First: The measure on calendar first on the list at the time for making report shall be entered on said report and the vote thereon shall be reported, first by district, secondly by state and thirdly by the national Union.

Second: No more than three different measures shall be entered on calendar at any one time.

Third: But one measure shall be entered on calendar at any one meeting.

Fourth: All measures formally and legally adopted shall be entered on calendar in the order of their adoption.

Fifth: When no other business is pending the union may proceed to revise calendar, first, by erasing any measure, second, by making additions or abbreviations to any of the measures, third, by changing their numerical order on the calendar.

How could we conceive of a more potent means for education upon important public measures than this? But three measures can be on the calendar at any one time, and then there is the order of precedence! How the money reformers, the transportation reformers, the land reformers, prohibitionists, free traders and others would try to get recognition on the calendar and at the head of the list, and how the people would study and investigate when they would know that upon them rested the responsibility for the rejection of the "mint, anise and cummin," and the acceptance of the "weightier matters of the law!"

Why stand we here idle when such a means for the education of the masses and the overthrow of the money power lies within our grasp? As the love of money, which is the root of all evil, has been suffered to take possession of the plastic forms of our government, let us now learn to accept the means for the restoration of a more righteous love, the love of humanity, to again take possession of those susceptible forms, and to breathe into them the quickening breath of a new life.
