ADJOURNED MEETING OF THE CITY COUNCIL. COUNCIL CHAMBER, } CAIRO, Ill., Jan. 14, 1873.

Present.—His Honor Mayor Lansden and Aldermen Cunningham, Hurd, Phillips, Robinson, Safford, Stratton, Swayne, Taylor and Woodward.—10.

On motion of Alderman Swayne the reading of the minutes was dispensed with. GRAIN INSPECTOR.

The mayor stated that in accordance with the request of the council, he had appointed a committee of five merchants to report to the council in relation to the appointment of an inspector of grain and of other articles of commerce, said committee consisting of D. Hurd, J. B. Phillips, Z. D. Mathus, T. W. Halliday and E. F. Davis.

Alderman Safford moved that the ordinance in relation to the appointment of a grain inspector be laid over until the above mentioned committee submit their report. Carried.

Be it ordained by the city council of the city of Cairo, Illinois, that the following described ordinances and parts of ordinances be amended as follows, viz: SECTION 1.
