
The Golden Eagle started for Black

River and was forced to return. The
ice had mostly been drifted up by the
southerly wind, and was several feet
thick.

Wymann round and left him
open for attack. Fell saw his chance
and quick as lightning shot out his
powerful right, struck Wymann on
the neck, knocking him clean off his
feet. Wymann fell heavily on his face
and being unable to come to time in
the required ten seconds, the victory
was awarded to Fell—also at least
\$800. It is stated by some that Fell
and his backers carried at least \$1,500
of the Alpena sporting men's money
away with them.
The gloves used are known as hard
gloves, and are but little softer than
if mere leather gloves were used.
Wymann was considerably marked
about the face. Fell did not have a
mark on him and did not receive a
blow of any account. He would like
to get lots of such easy chances to
earn from \$800 to \$1,500.
Only half the required stakes had
been put up by Wymann's backers a
short time previous to the fight, and in
order to save that amount, and the fight
could go on, a subscription paper was
circulated, and the other \$250 was
soon raised.
The spectators each paid 25 cents
per minute to see the fight, dead heads
not included. About one hundred
men watched the fight from the side-
walk in front of the store of Klock,
Donnelly & Co. They did not see
much except the backs of some specu-
lators who sat near the Opera House
windows. They were one dollar ahead
by not going in and had as much fun
as those who were inside.
Wymann thinks Fell had a steam
pile driver fastened inside his glove.
Fell's crew was five strong. They
came by special stage, and left for
Black River Sunday afternoon. Wy-
mann went to see them off. As they
drove away Wymann remarked mourn-
fully "Them — — are carrying a
pile of money away with them."
Before the fight Fell was said to
weigh 156 pounds. After the fight
he weighed 192. He is not as tall as
Wymann by several inches.
The best thing Wymann can do is to
give up the fighting business and go
to work. He ought to be a good man
at handling a pike lever.
We sincerely trust that another of
these slugging matches will not take
place in this city. They are no ben-
efit or credit to Alpena.

The retiring members of the Council
are Mayor Harshaw and Alder-
men Warner and Cuning. Mayor
Harshaw has made a good presiding
officer and has worked for the inter-
ests and improvements of the city.
Alderman Warner leaves with the
reputation of being one of the best
the city has had. Alderman Cuning
was appointed to fill vacancy, and
only served a few weeks.
A fine set of heavy harness has re-
cently been manufactured at the shop
of D. D. Hanover, for one of the
dray teams of E. A. Furbush. It is
a beauty.

Arrangements had been made last
week whereby the steamer Golden
Eagle was to run between Alpena and
Osineke and connect at the latter
place with the stage at Black River.
Her first trip was to be made on Friday,
but the wind had blown the ice from
the north shore of the bay and thus
prevented the steamer from getting
to Osineke. The consequence was
that passengers had to come to town
by stage the remainder of the week.
Ice on the shore also prevented the
Eagle from making trips to Black
River.
The first team crossed the new
bridge last Friday, being Phelps'
ponies. The bridge is completed and
ready for the public, but the ap-
proaches are not yet ready. The
abutment at the end of Second street
is being strengthened on account of
the break at one end. The bridge is
painted red, with the exception of the
tie rods and the iron lattice work at
each end, they being white. It is ex-
pected the approaches will be com-
pleted next week and the bridge
opened to the public. The old bridge
will then be torn down and the north
protection pier completed.

The widening of the gauge on the
shore road to the standard width be-
gan at Alger last Sunday, a large
number of men being engaged in the
work. The force reached East Tawas
at noon to-day, where work will be
suspended until Sunday next, when
they will go on to Au Sable, thence
to Black River. The rolling stock
for the standard gauge has been or-
dered, but not being yet quite ready
a passenger train, including locomotive,
is being used on so much of the track
as has been widened. Just what the
effect the changing of the gauge will
have on the shore business we can only
conjecture. Some think it will

help us, others that a good deal of the
pine which would otherwise be manu-
factured here will now go to the Sag-
inaw valley mills.—Tawas Gazette.
