MICHIGAN NEWS ITEMS IN BRIEF

Paragraphs of interest to Wolverine State Readers.

News of All Kinds Gathered From Various Points in the State and So Reduced in Size That it Will Appeal to All Classes of Readers.

Grape growers report that they are not looking for a full crop this year.

The new industrial building at the Kalamazoo State hospital has been started.

Adam H. Wagner, aged eighty years, Sturgis pioneer, died at his home, aged eighty.

The construction of a new ten-story First National bank building in Kalamazoo will begin in the immediate future.

On June 12 the Kalamazoo Gazette, claiming to be the oldest newspaper published in Michigan, became an evening paper.

Mrs. Elizabeth Lefebvre, 70 years of age, of Jackson, Mich., was struck and killed by an automobile driven by E. M. Williamson.

Reports by police of Kalamazoo for May show an increase in the number of arrests made in that city for drunkenness during the past 30 days.

John Mack, man of mystery, whose name, years ago, was linked with the famous Beacraft counterfeiters, is dead at Flint city at the age of ninety-six.

Edward Badgley, twice committed to Kalamazoo hospital for the insane, suffered a mental relapse because of interest in the Republican national convention.

What Three Rivers people promise to be the biggest canteloupe crop ever raised in Michigan is now being planted. Thousands of plants are being set out.

To maintain the fund started by her father for the city's poor, Mrs. Clara Louise Peck Waite, wife of Dr. Arthur Warren Waite, has sent Superintendent A. A. Carroll at police headquarters a check for \$100.

The police of Grand Rapids have begun an investigation of two mysterious fires which followed each other, destroying the plant and dry kilns of the Valley City Chair company, causing a loss which will reach \$200,000.

Positions are reported to have been found by the employment committee of the engineering college of the University of Michigan for almost every graduate of the college, according to an announcement made at Ann Arbor.

For a better condition among the weekly newspapers, the editors of all 44 Buren county papers have united. A. N. Moulton, of Decatur, has been elected president, and C. E. Lewis, of the Lawton Leader, secretary and treasurer.

Suit for \$20,000 was instituted in the circuit court at Kalamazoo against Charles W. Wright by Ernest Smith, who alleges that he was injured when struck by an automobile driven by Wright's son. Smith says that his neck was broken.

Henry H. Swan, 76, former judge of the United States District court at Detroit, died at his home in Gross Point, a suburb. Death was due to pneumonia. Judge Swan retired from the bench in 1911 after serving twenty years as federal judge.

Fears of a double drowning at South Haven, proved groundless when William and Charles Anders, aged thirteen and ten years, were located at the home of a neighbor, where they had sought shelter after running away from home.

Karl von Papen, alleged German reviser and observer tried at Pontiac, who was convicted of embezzling \$276 from John F. Deacon, of Detroit, his employer, was sentenced to from one to five years in Jackson prison with a recommendation of two years.

Although Miss Mary E. Spaulding, a Grand Rapids girl, posed for a life-sized photograph in nothing but tights, and a thin pair of shoes, a jury in the circuit court has awarded her \$2,500 heart balm against David McWhorter, a retired business man.

When Attorney Milo Bennett at Kalamazoo learned that Prosecuting Attorney Frank Ford held another warrant for the arrest of Harry F. Irvine, to be served if Irvine should gain his freedom on habeas corpus proceedings, Mr. Bennett withdrew his petition.

Sheriff Ralph Chapman, Kalamazoo county, is having difficulty in riding the county of pyreles. Numerous thefts are said to have been committed by them and women prophets are forcing their way into homes and forcing women to give them money or other articles.

Thursday, June 15, at the state capitol marked the retirement from active service of Brooklin S. Carlton, messenger for the Michigan supreme court. For more than eighteen years Mr. Carlton has carried the mail for the court and its members to and from the Lansing postoffice.

The Manistee life-saving crew dragged Manistee river in the belief that Edward Lukowski, aged seven years, who has been missing, fell off the Northern Michigan Transportation company's dock, and was drowned. The child failed to return home after he had been sent on an errand.

Mrs. Emmeline Cope, of Kalamazoo, a pioneer suffrage leader of Michigan, died after a long illness.

Robbers entered the Mendon First State Savings bank, and escaped with \$400 and a quantity of revenue stamps.

Mrs. Augusta Rae, of Marshall, wife of the former cashier of the City bank of Battle Creek, began suit for divorce.

An unsuccessful attempt to dynamite the mill dam of the F. W. Stock & Sons flouring mill at Hillsdale was made.

J. F. McCann is the new postmaster of Ypsilanti. Mr. McCann was born at Ypsilanti in 1877 and has been a resident ever since.

The postoffice in Mackinac Island will be boosted into class presidential July 1, as the salary of the postmaster will be \$1,900 per annum.

Injury by his motorcycle colliding with a heavy automobile near Cedar Springs, caused the death of Harold Sadner, twenty years old, of Sand Lake.

According to the results of the school census of Ann Arbor just announced, there is a total school population of 3,888. This is an increase of 162 over last year.

C. E. Chipley, secretary Sault Ste. Marie Civic and Commercial association, received word from Congressman Frank D. Scott that Fort Brady is soon to be re-established.

Former Representative Christopher Babcock, of Branch county, eighty-years of age, died at his home in Bronson. He had resided in the county more than half a century.

When flames threatened at Kalamazoo to destroy the Dawson residence, the dead body of Jacob Dawson, who died the day before, was hurriedly carried from the house.

Points of interest at Mackinac Island is included in a bulletin just issued by the Michigan historical commission. The volume may be obtained by request of anyone interested.

Kendall Steklee, aged 22, well known Grand Rapids young man and professional dancer, died in Chicago. Paralysis, brought on by excessive dancing, was the cause of death.

J. J. Forsythe, 70, Kalamazoo, an official of the Bryant Paper company, and one of the best known paper manufacturers in the middle west, died in Chicago. He leaves four sons, all employed in paper making.

June 15, 1915, Miss Fern Estabrook, a Landsome Allegan girl, and a demonstrator for a pure food company, met Oscar Krozen, Jr., of Milwaukee, Thursday June 15, the two were married at Kalamazoo.

H. H. Woodruff, aged 75, a pioneer resident of Roscommon county, one of northern Michigan's prominent attorneys, and a member of the constitution convention, died at his home at Roscommon of heart disease.

Thos. Hewitt, aged 57, merchant of Schoolcraft, died in a Chicago hospital of a fracture of the skull and internal injuries sustained June 10 when he was struck by an automobile at East 23d street and Indiana avenue.

The Detroit Edison Co. made the village of Plymouth an offer of \$50,000 or the local electric plant. The council has adopted an ordinance accepting the offer which will be submitted to the electors at a special election June 19.

Alfred Lucking, a young lawyer, Detroit, has been admitted to practice before the District of Columbia supreme court in order to qualify as counsel for Henry Ford in the libel suit brought against the latter by the Navy League.

In the circuit court, the will of the late Henry J. Nibbellink, of Grandville, who left an estate of \$52,000, was changed so that Mrs. Elizabeth Medemar, a daughter, receives an equal share of the estate with her four brothers.

Because Theodore Hollis, just back to Grand Rapids became involved in a quarrel in a local cafe he will have to complete a fifteen-year sentence in Marquette prison, of which he has served but two years. Hollis was recently paroled.

Wife home to mamma, back in Indiana, hubby sore and a \$10,000 suit against daddy-in-law, these are some of the results of an elopement of Kalamazoo a year ago when attractive Miss Pauline Curnisk, of Indianapolis, became the bride of Samuel Juvet.

After hundreds at Toledo, Ohio had viewed the body of a murdered woman found on the streets early in the day, Mrs. Charles Quinn late in the afternoon positively identified the body as that of her sister Nellie Spoelstia, twenty-two years old of Grand Rapids.

The state tax commission of Michigan has passed another of the New York Central mortgages. It was filed in Washtenaw county and is for \$0,000,000. The commission fixed the tax under the specific mortgage law is \$37,059, all of which goes to Washtenaw county.

The 43d annual meeting of St. Joseph County Historical & Pioneer society was held at Centerville. The business meeting was followed by a dinner, Dr. Marden Sabin, of Centerville, one of the pioneer physicians of the county, retired as president and Frank Yaune was chosen to succeed him.

The Lansing police authorities have practically abandoned the theory that Alex. M. Somogyi, Hungarian banker who was shot and killed last Friday night, was the victim of bandits, and are now working on the idea that Somogyi came to his death as a result of some wrong done by him to some countryman.
