RETROSPECTIVE

Fifty Years Ago.
From the Banner of April 7, 1866—Bellevue.
"President Andrew Johnson has vetoed the 'Civil Rights Bill.'"
"The Supreme Court of Louisiana has decided that Confederate money deposited with a bank creates no contract which can be recognized."
"The Radical strength in the House of Representatives at Washington was shown when that body voted down, 37 to 126, Thad Stevens' substitute for the Freedmen's Bureau Act, wherein was embraced Stevens' pet theory that the South was conquered territory to be parcelled out among the victors."
"The negroes in the Michigan colored regiment who have come back from the war have gone to suing Col. Henry Barnes, a super-loyal and high-flamed fanatic, who first organized the regiment, for the recovery of their bounties which Barnes thrust into his own pocket. Some forty suits have already been entered."

"For all my notes, made since the surrender, I will pay in lumber, a premium of 10 per cent. Persons will take due notice and charge nothing to my account without an order from myself or Capt. John W. Smiley.—H. R. L. Winfrey."
"Our exchanges attribute the fall in cotton prices to the very flattering prospects for a cotton crop. If this parish can be taken as an example, we can't see anything so very flattering. We have heard of the hands on several plantations taking a 'stampede' and all leaving at once, without giving the planter an hour's notice. These stampedes may be expected often. The majority of the hands do a third less work than formerly, and at least a fourth of former field hands are not tilling the soil. The towns and villages have absorbed a large number of farm laborers, and it is a very common thing for the husband to enter himself as a hand, but keep his wife and small children, and occasionally a grown daughter, at home to take care of his cabin."

Thirty Years Ago.
From the Banner of April 8, 1886—Bellevue.
"The through rate of fare from Chicago to San Francisco is only \$16 because of the war between the transcontinental lines."
"A sufficient cause for removal of Republicans should be that they are Republicans, and that Democrats will be held responsible for the way affairs are administered. Bounce the Republicans." (Cleveland was then President).
"Let Democrats beware of both muggumps and stalwarts. Either party would if it could annihilate the Democratic party. They differ only in methods of warfare. What matter if it is a pur or a roar which comes out of the jungle so only a wild beast is there."
"Commissioner of Pensions Black stated before a Committee of the United States Senate the other day that certain papers on the files of his office had been tampered with by Republican clerks, or words to that effect. That is what comes of sham Civil Service Reform."

"Following is the vote polled in this parish for Hon. W. W. Vance for State Senator Tuesday: At Collinsburg, 32 votes; at Red Land, 9 votes; at Rocky Mount, 18 votes; at Bellevue, 32 votes; at Fillmore, 51 votes—total, 141. Up to the time of going to press the returns from Wards One and Two have not been received." (Hon. W. W. Vance was a lawyer of Bellevue and afterward became Secretary to the Governor and died in Baton Rouge. He was a law partner of J. A. W. Lowry of Bellevue, a lawyer of great popularity and local fame. The farmers and, in fact, everybody else used to crowd the court house to hear Lowry talk. He is long since dead.)

Ten Years Ago.

"A six-story business building will be erected by Mrs. E. M. Busby on the southeast corner of Milam and Market streets, Shreveport, for the recently organized American Savings Bank and Trust Company. The site upon which the building will be erected is now occupied by the old David Pobst blacksmith shop, which was erected about sixty years ago, and is one of the oldest, if not the oldest, business building now standing in Shreveport."

Levee Board Proceedings.
A meeting of the Board of Commissioners of the Bossier Levee District was held this day, Friday, March 31, 1916, at the office of the board, 527½ Spring Street, Shreveport, La.
The President, A. Curtis, called the meeting to order, with the following members present: Messrs. A. Curtis, E. B. Herndon, W. H. Hodges, Jr., J. H. Mercer, W. C. Raines and W. B. Wilbourne, Mr. T. W. W. Stinson being absent.
It was moved by Mr. Hodges and se-

conded by Mr. Raines that the board go into executive session to consider the bids submitted for leasing the lands of the Bossier Levee Board for oil and gas purposes. The motion being duly put was unanimously adopted.
The board went into executive session as a whole, considered each bid in detail and, after due discussion, awarded lot 6, section 9, lot 2, section 14, and lot 3, section 13, township 16, range 12, Bossier Parish, Louisiana, containing 77.02 acres, more or less, to the Palmetto Oil Company, and awarded lots 5, 6 and 7, section 21, township 16, range 12, Bossier Parish, Louisiana, containing 109.90 acres, more or less, to the Gulf Refining Company of Louisiana, said companies, in the opinion of the board, submitting the best and most favorable bids.
The secretary was directed to advise said successful bidders that their bids were accepted and to allow them a reasonable time to examine the title to said lands, etc., and submit executed leases, in compliance with their bids, to the secretary for his approval and submission to the president of the board for his execution.

The secretary was ordered to investigate the swamp and overflow lands within the Bossier Levee District to which it has not heretofore received deed from the state, and to which the board is legally entitled, and to obtain a deed therefor from the Register of the State Land Office, or Auditor, or both, as provided in Section 9 of Act 89 of 1892 of the General Assembly of the State of Louisiana.
There being no further business before the said board, the meeting adjourned.
