Why the Town is Orderly—A Budget of News from the Bay City and its Vicinages. MORGAN CITY, LA., Nov. 23, 1885. EDITOR CHIEF: I notice you clip from the Review an article stating that "Morgan City is the most orderly town in the State; that the Mayor's court is seldom in session, and that the corporation has a very orderly one, I admit, but it is not owing to the great promptness and energy displayed by said Mayor or our "one policeman"—it is altogether owing to the disposition of our citizens, both white and colored. The Mayor's court is seldom in session—not that there is no business to attend to, but the Mayor has too many things on his fire; he is Mayor, deputy coroner, city officer, only practicing physician for several lodges and holds other offices. I believe, in those organizations. THE DEAD KING.

Alfonso, the Sovereign of Spain, is Gathered to His Fathers.

While the people of the United States are mourning the loss of Vice President Hendricks, those of Spain are bewailing a national misfortune of a kindred character. On Wednesday last, November 25, the same day Mr. Hendricks passed away, Alfonso XII, the consumptive young Spanish King, died at El Pardo, near Madrid, after two days of intense suffering. His health had been in a precarious state for some time and the constitutional weakness of his physical organization has been well known, but it was Tuesday morning, scarcely twenty-four hours prior to his death, ere he would permit a knowledge of his alarming condition to be communicated to the royal family and the officers of his Cabinet. The scene at the death bed was very affecting. The last sacrament of the Catholic church was administered at 7:30 o'clock a. m., and at 8:45 the royal corpse expired in his wife's arms, while his mother and sisters knelt weeping beside the couch. The King had expressed a wish to see his little daughter, but they were in Madrid and did not arrive until after their father had expired.

Alfonso XII was born November 28, 1857, the second child and eldest son of Isabella II, then Queen of Spain, who was dethroned in September, 1868, and left the country with her family, taking up her residence in France, where she has since lived. A Provisional Government succeeded the revolution, and was in turn followed in 1869 by the Regency of Marshal Serrano. In 1870 Prince Amadeo of Italy was chosen King of Spain, but he resigned the crown in 1873 and went back home. Then came the Republic, followed in December, 1874, by the election of Alfonso as King. He was crowned January 9, 1876, and has occupied the throne since that time, giving the country an administration as peaceable and popular as is possible in a revolutionary Spain. His concern for the happiness of his subjects, his brave conduct during the recent cholera epidemic, and the successful termination of the still more recent controversy with Germany relative to possession of the Caroline Islands combined to increase his popularity, and he died almost universally beloved by the Spanish people.

In January, 1878, Alfonso married his cousin Princess Maria de las Mercedes, who died the same year. In November, 1879, the young widower espoused the Archduchess Maria Christina of Austria, who survives him. They have had two daughters, the elder of whom, Princess Mercedes, aged 5 years will be proclaimed Queen, under the regency of her mother, unless the expected posthumous child should happen to be male.

FOREIGN.

Bismarck is suffering from neuralgia. The Servians were defeated at Shirlitz. The Belgium budget shows a surplus of \$300,000. The Senate is being stocked with American salmon. The Borneese are blockading the Irrawaddy river. The English troops captured important forts in Borneo. Forty-two cardinals have died during the reign of the present Pope. Munkar Fasha has been appointed Turkish commissioner to Egypt. The Amer of Bokhara is dead and will be succeeded by his son, Seid Abdolnab. The powers have instructed Prince Alexander of Bulgaria to agree to an armistice. Belgium is negotiating with France with a view to re-entering the monetary union. The Pope has declined to receive Don Carlos except on absolutely private footing. Germany and Spain concluded their negotiations touching the Caroline question. America and England have claimed damages for injury to their subjects in the Caroline Islands. Subscription lists have been opened throughout Austria and Hungary in aid of the Servians. Prince Alexander, at the head of 6000 Bulgarian troops, has entered Servia and captured Pirot. Austria, fearing for the position of King Milan, has joined Germany in urging Turkey to intervene. The English government intends prosecuting the London Town Talk for alleged indecent publications. The United States government has requested protection for American missions on the Caroline Islands. The difficulty between France and China has been removed and negotiations between the two nations resumed. An armistice between Bulgaria and Servia has been declared and King Milan has given orders to his troops to cease hostilities. The natives of Fly river region have murdered all the members of the Sidney Geographical Association expedition in New Guinea. One question discussed at the late missionary conference in Omsk, Japan, was whether it is better that missionaries should be sent out married or single. Over 5000 people have been drowned and villages submerged in Jessore, Calcutta, by a cyclone and 234 square miles in the Moorshedabad and Huddid districts devastated. The Emperor of China is favorably disposed toward the American railroad system and is ready to grant concessions to an American corporation and guarantee the bonds it issues. Herr Jost, the African explorer, says during his late travels in Zululand, he found the remains of Cetewayo, unburied, shut up in a hut and mourned over for two months by 500 women.

The Chinese Ministry at Washington is soon to give a ball. The Pennsylvania Legislature is to have an extra session this winter. The Penobscot Indians have a representative in the Maine Legislature. The removal of the dead miners from the Bull Domingo mine has begun. A female school teacher in Pike county Ind., whipped a child till it died. Thomas James of Gainesville, Fla., is the father of fifty-three children. There will be only four colored men in the next General Assembly of Virginia. H. B. Claffin, the great dry goods prince of New York, died recently of apoplexy. George W. Cable is a Sunday school teacher at his new home in Massachusetts. A special train carried forty-five tramps out of Galveston a few miles and dumped them. A colored preacher in Alabama is 103 years of age, has had nine wives and 117 children. Ten thousand dollars reward is offered by a Nashville preacher for a case of bona fide faith cure. The colored orphan's Home at Chattanooga was destroyed by fire on the morning of the 22nd. At Loganport, Ind., Mrs. Mollie Brown, a bride of only six days, ran away with a professional thief. A widow of 67 years, with ten grandchildren, has married a boy 15 years old, at Port Jarvis, N. Y. "The Leland Stanford, Jr., University" is about to be founded by the mourning millionaire, Senator Stanford. A young lady at Bellaire, O., fell into a syncope at a skating rink, attributed to tight lacing and over-exertion while skating. Forty persons were poisoned at Chattanooga by drinking from a well into which a quantity of Roush on Rats had been poured. Mrs. Colton, living near Honesdale, Pa., has been only married ten years, and is the mother of three sets of triplets and a couple of twins. It is now estimated that the loss by the great Galveston fire will reach \$2,000,000. New York has contributed \$1250 and Jay Gould \$500 for the relief of the sufferers. The entire surface of the Egyptian Obelisk in Central Park, New York, has been coated with paraffine to arrest the crumbling away of the shaft which began some time ago. The four sons of Lieut. F. L.
