Successful interscholastic Meet.

Owing to lack of space, a detailed account of the athletic and literary meet held at Napolsonville last Saturday, and participated in by the Donaldsonville, Napolsonville and Houma high schools, is unavoidably omitted from today's Chief. Houma carried off first honors in the athletic contests with a total of 56 points, Donaldsonville coming second with 46 and Napolsonville third with 37. The basketball game between the Donaldsonville and Napolsonville teams resulted in favor of Donaldsonville by a score of 23 to 12, but in the baseball game Napolsonville got revenge by trouncing the locals to the tune of 6 to 1. The declamatory contest between Donaldsonville and Napolsonville was won by Miss Annie Oubre of Donaldsonville over Berthold Alves of Napolsonville. The Houma glee club was adjudged the winner of the chorus contest.

Damage Suit Filed.

Mr. and Mrs. Armand LeBlanc, of this parish, have filed suit in the district court at Baton Rouge against the Louisiana Railway and Navigation Company and the Baton Rouge Electric Light Company for damages in the amount of \$30,000, claiming this sum as recompense for the death of their son, Thomas LeBlanc, who was killed at Baton Rouge in August, 1907, by being knocked from a freight car of the Red River Valley road by a trolley wire of the Baton Rouge street railway company. The petition of plaintiffs alleges that the wire had been lowered during the preceding day about four feet, and that there was not sufficient room to allow a person to stand on top of a car without being struck by the wire. The L. R. and N. Company is brought into the suit because of the allegation that the road did not warn LeBlanc, who was one of its employees, that the wire had been lowered. The unfortunate young man was knocked between the cars and killed almost instantly.

Knights of Columbus initiation.

Ascension Council No. 1087, Knights of Columbus, held its third annual initiation of candidates last Sunday, conferring degrees upon fifty-four applicants for membership in the great Catholic order. A special train from New Orleans over the T. and P. Railroad brought up about 500 Knights, and in addition there were large delegations present from Napolsonville, Thibodaux, Whitecastle, Plaquemine, Baton Rouge, Alexandria and other points. The visitors were met by a committee of local Knights and escorted to the courthouse, where the candidates for initiation had assembled to await their coming. At 10 o'clock a procession of St. Vincent's Institute, where a tempting lunch was served by the mothers, wives, sisters and sweethearts of the members of Ascension Council. At 1 o'clock the conferring of degrees was begun under the supervision of State Deputy George W. Young of New Orleans, assisted by Grand Knight D. B. Haggerty and Deputy Grand Knight John B. Fisher of Orleans Council, the initiatory ceremonies being until 7 o'clock.

DISTRICT COURT.

First Week of April Criminal Term—Grand Jury Submits Its Report—Record of Business Transacted to Date.

A regular semi-annual term of criminal district court was convened at the courthouse at 10 o'clock Monday forenoon, with Judge Paul Leche on the bench and a full attendance of other officers and members of the bar. The following grand jury was impaneled to serve for the ensuing six months: James Fortier, Theo. Duhon, Alex. N. Marchand, J. W. Stephenson, F. K. Sims, Lucien Gautreaux, Van Gaudin, Leo Melancon, Vileor Bourque, H. P. Picou, Cyrille Babin and Frank Stampley. Judge Leche named Mr. Fortier to serve as foreman of the jury and delivered a forceful and comprehensive charge to that body, calling the attention of the members to the duties incumbent upon them as grand jurors.

District Attorney G. A. Gondran, who has been quite ill for the past fortnight, appeared at his post of duty when court opened, but immediately after the impaneling of the grand jury he stated to the court that his physical condition was such that he was unable to continue his work this week, and requested the appointment of a district attorney pro tem. The court thereupon appointed Hon. R. M. McCulloh to serve during Mr. Gondran's illness.

Sessions of court were held Tuesday, Wednesday, Thursday and Friday, adjournment to 10 o'clock a. m. next Monday having been ordered at the conclusion of yesterday's sitting.

On Tuesday afternoon it was discovered that one of the grand jurors, Cyrille Babin, had been improperly served, and hence all of the proceedings of the inquisitorial body up to that time were null and void. The error was remedied by the appointment of J. Rumsey Duke to take Mr. Babin's place, and the jury proceeded with its deliberations.

The jury submitted a partial report Wednesday afternoon, and the following morning presented its final report and was discharged until further notice. In its final report the jury declared that the courthouse is in need of repairs, particularly the walls of the clerk's vault, the cracks in which are said to be a menace in case of fire. A fireproof vault is recommended for the treasurer's office, and the public school system in Donaldsonville is highly complimented. Attention is called to the practice of public gambling in box cars around Bullion station and other points on the line of the L. R. and N. road.

Dixon-Duplantier.



Telephone Hearing.

The petition of the subscribers to the Cumberland Telephone and Telegraph Company asking for better telephone service between Donaldsonville and the opposite side of the river was taken up by the railroad commission at Baton Rouge on April 23, and the following opinion has been rendered by the commission:

The petition in this case is signed by a number of users of the telephone service of defendants living in Ascension parish on the east side of the Mississippi river who desire service at the telephone exchange at Donaldsonville. The complaint is that the Cumberland Telephone and Telegraph Company refuses to relay a submarine cable across the Mississippi river at Donaldsonville in place of the cable which has only recently been lost in the river.

The records of the commission show that the defendant telephone company has laid a number of cables across the Mississippi river at Donaldsonville and each one has been completely lost. In fact, the destruction of submarine cables across the Mississippi river occurs with great frequency and this trouble has grown to be a matter of serious consideration from an engineering standpoint.

The commission, however, realizes the importance of the demand for the laying of these cables and suitable crossings and the value of such service to the patrons of the company. It has been suggested that independent companies might lay these cables and maintain them in the same manner as bridge companies construct and maintain bridges across large streams, charging for the use of the cables a fixed rate per message. Whether this plan is feasible, the commission cannot without a much deeper investigation than it has made in this case say. It remains, however, a fact that the commission is not, at the time of the filing and consideration of this complaint, vested with power to require the telephone company to lay cables across the river; or, in fact, to require any investment of money in the extension of lines, except in the giving of equal facilities to parties desiring telephone service in exchange ratio. It is for this reason that no order is entered in this case, granting the request of petitioners, and the case is therefore dismissed.

He himself declared that the juice of the malt was never absent from his board.


