POLICE JURY PROCEEDINGS.

(Continued from page one.)

In testimony whereof I have hereunto affixed my official signature at the parish of Ascension, La., this 15th day of May, 1914.

Mr. Spahr offered the following ordinance:

Be it ordained by the police jury of this parish that in accordance with the foregoing petition signed by more than twenty-five land owners of the Smoke Bend Drainage District, Messrs. Camille Rome, Hank Acosta and Thomas Bradford be and they be hereby appointed members of the board of commissioners of the Smoke Bend Drainage District, the said Camille Rome for a term of four years, and the said Hank Acosta and Thomas Bradford each for a term of two years from date hereof.

The resolution was seconded by Mr. Orsuro, and on roll-call adopted by a vote of 8 yeas and no nays.

Mr. Spahr offered the following resolution:

State of Louisiana—Parish of Rapides.

For vote received, Frederick E. Rogers does hereby transfer, convey and deliver unto Gailley & Clark a partnership domiciled in the parish of Rapides, state of Louisiana, composed of A. J. Gailley and H. C. Clark, both residents of the parish of Rapides, and the said said parish of Rapides, and to the contract between the said Frederick E. Rogers and the said Gailley & Clark, dated April fifteenth, 1914, relative to road construction in said parish.

And the said Gailley & Clark, herein represented by the said A. J. Gailley, does hereby accept said transfer and binds and obligates itself, its successors and assigns and the members of said partnership, to assign, to the said Rogers as contractor under said contract of date April fifteenth, 1914, and shall be so treated and considered by the police jury of said parish of Ascension.

This contract is entered into subject to the approval of said police jury of said parish of Ascension.

Signed in triplicate originals by the parties hereto, each party to retain an original and the third original to be handed to the police jury of said parish of Ascension, on this ninth day of May, A. D. 1914.



Resolved, that said police jury of said parish of Ascension do hereby approve of the transfer and assignment made as aforesaid by the said Rogers to the said Gailley & Clark, and the said police jury of said parish of Ascension is hereby authorized to accept the bond and surety that may be furnished by the said Gailley & Clark, in accordance with the terms of said original contract.

Be it resolved, that when the finance committee of the police jury proposed the budget of expenditures for the fiscal year 1914-15, they shall include therein an amount to be used for the demonstration farm work throughout the parish.

The resolution was seconded by Mr. Causer, and on roll-call adopted by a vote of 8 yeas and no nays.

Mr. Causer offered the following resolution:

Be it resolved, that the finance committee of the police jury be and it is hereby authorized to prepare a budget of parish expenditures for the fiscal year 1914-15, which shall be published in the official journal of the parish of Ascension for a period of thirty days, as required by law.

The resolution was seconded by Mr. Gautreau, and on roll-call adopted by a vote of 8 yeas and no nays.

A committee of residents of Port Barrow appeared before the jury for the purpose of protesting against the proposed street crossing over the street in Port Barrow. After considerable discussion, the whole subject was referred to the district attorney, who advised the parish, to investigate and ascertain if the said street has ever been dedicated as a public road, and if so, the district attorney to make his report to the committee of residents of Port Barrow.

Mr. Spahr offered the following resolution:

Be it resolved, that J. C. Klos be and he is hereby appointed as a representative of the police jury to assist the assessor in making an adjustment of the assessments throughout the parish, and that his compensation, as such be fixed at the sum of \$5.00 per day, for each day actually at work.

The resolution was seconded by Mr. Orsuro, and on roll-call adopted by a vote of 8 yeas and no nays.

Mr. Armitage offered the following resolution:

Be it resolved, that the sum of forty dollars be and the same is hereby appropriated to pay the salaries of Geo. Dade.

The resolution was seconded by Mr. Gautreau, and on roll-call adopted by a vote of 8 yeas and no nays.

The matter of filling the vacancy in the office of constable in the first ward of the parish of Ascension, in the person of a deputy sheriff to the sheriff, was deferred until the next meeting of the jury.
