With the Farm Agents.

Some members of the sweet potato and cotton clubs are running fertilizer experiment plots in connection with their regular club work, reports W. M. Crumpton, agent in Lincoln parish.

The purchase of purebred pigs by club members in some communities has caused farmers to buy purebred stock, writes H. H. Hester, agent in Red River parish.

On Wednesday and Thursday of this week, P. W. Spencer, corn club agent, met with clubs at Sunny Hill, Mt. Hermon and Franklinton, at which time these clubs went into permanent organization, reports J. V. Rabb, agent in Washington parish.

The best prospect for outstanding results in club work was noted in the cotton club patch of Owen Sayes of Vick, writes F. A. Swann, agent in Avoyelles parish. This club member has his soil in perfect state of cultivation, has applied the necessary fertilizers, has used standard-bred seed, and judging by his past records, he will keep up his good work.

Twenty-five members of the Pine Grove Club, Rapides parish, attended a picnic and fish-fry this week, reports B. W. Baker, assistant parish agent. Mr. Baker says that such affairs are very stimulating to club interest. Other club rallies will be held on the next three Saturdays.

Two canning and sealing outfits for girls, and seed corn for 47 corn club boys were received this week, writes Geo. W. Bohne, agent in Allen parish. This was made possible through the generosity of the banks, chambers of commerce and individual contributors to a club fund which has been placed in the agent's hands for such purchases as may be necessary to carry on club work.

Regular visits to club members every two weeks are made by J. J. Mixon, agent in Natchitoches parish. Each member is required first to make either a verbal or written report on all work done, after which instructions are given for the next two weeks. We find that club work must have regular attention to get anything worth while done, comments Mr. Mixon.

CIVIL SERVICE EXAMINATIONS.

Opportunities to Qualify for Federal Government Positions. The United States Civil Service Commission announces examinations as follows for positions in the government service in New Orleans: Aug. 7, stenographer and typewriter; Aug. 18, deputy shipping commissioner.

The next examination for railway mail clerks will be held Aug. 11. For the following no written examination is required, the grades being determined by experience and like considerations, and applications will be accepted until the date stated: Aug. 24, associate in clinical psychiatry and psychotherapy; girls' athletic director. Aug. 31, assistant biologist qualified in bird migration; assistant director of statistics; assistant in the office of information, Department of Agriculture; pharmacist, Oct. 1, assistant teacher, federal board for vocational education. Until further notice, training officer, training assistant, placement officer, placement assistant, district medical officer, and assistant medical officer, federal board for vocational education.

Application blanks and necessary information concerning any of these places to be filled may be secured from the Civil Service Commission, Washington, D. C., or from the secretary, tenth civil service district, customhouse, New Orleans, La. Circulars may be seen at the office of the Chief.

The shareholders of the said corporation, appearing further declare that at said meeting of stockholders, held as above set forth, there were present in person or by proxy held by other stockholders of the corporation, duly executed, stamped and filed, stockholders owning two thousand two hundred and fifty-five (2,255) shares of the said corporation, representing more than two-thirds of the total outstanding stock of said corporation.
