The class of 1901 are holding some very important positions, while others are pursuing special lines of work.



Persistent Rumor That Toney and Baker Will Have Opposition.

Will Toney and Baker, the Democratic nominees for the House of Delegates, have opposition in the form of independent candidates? This question is being asked seriously in Manchester and Chesterfield, as the rumor is abroad that the marked dissatisfaction in the convention will lead to an independent ticket being put up.

Judge J. M. Gregory, who went into the convention with fourteen delegates from Chesterfield, but declined to allow his name to be presented on account of an alleged combination between Toney and Baker, says he will not make an independent race, but intimates that he has reason to believe independents will be put in the field.

They Come to Form a National Tobacco Association, and Will Be at Work Here for Several Days.

THE PROGRAMME IS COMPLETE

The organization of a National Tobacco Association will be effected in this city during the present week. Tobaccoists, representing every section of the country, will come here to have a hand in the matter and the city, figuratively and literally speaking, will be turned over to them.


THE PROGRAMME. The preparations for the convention will be said to be complete. At the present time there are still a few minor details of the programme yet to be arranged, and one or two other matters in connection with the meeting to be decided upon, but they are of minor importance and can be attended to in a short while.

On Thursday morning next at 11 o'clock, by the president of the Richmond Trade Association, Mr. D. L. Larus, who will also deliver an address of welcome. The object of the meeting will be stated by Mr. T. M. Carrington, chairman of the Committee on National Tobacco Association.

Following the morning session a lunch will be served at the Exchange building. After this the convention will assemble again and will appoint all of the working committees—those to look after the convention report, the permanent officers, the constitution and the other matters to be considered on Friday, when, in addition to these, other matters of interest will be discussed. On Saturday the visitors will be entertained. There will be an excursion to Jamestown and an all-day excursion will be served on the steamer.

AN EFFORT will be made to wind up the meeting by Saturday night, but this is hardly possible. It is more than likely that there will be no opportunity for the election of permanent officers until the following Monday morning. The convention will probably adjourn finally on Tuesday. This holding over of the convention until the following week will be agreeable to many of the delegates. Several letters have been received here inquiring why the meeting will not be held during the time when the great show is going on. The delegates want to be here and see the fair. Special care has been taken that the delegates be given sufficient opportunity to amuse themselves while here, and will be provided with a badge, which will entitle him to all privileges, and, in addition, each will be furnished with a book of tickets giving free street-car rides, carriage drives and admission to the various attractions offered by the city. Arrangements for hotel accommodations have been made. The Tobacco Exchange building has been thoroughly overhauled and repaired, and will be handsomely decorated in honor of the occasion.
