PETTIT JURY DISCHARGED.
Orphans' Court's Busy Week, &c.

Circuit Court.
Court convened on Friday last to hear the suit of the Baltimore and Reisterstown Turnpike Company, in which the Stevenson Stone Plant Company was plaintiff. It was tried before Judge Forsythe. The suit was over stone sold to the turnpike company for which the plaintiff claimed \$1 a ton, just double according to the agreement, and the amount sued for was \$434.92. A verdict of \$217.46 was rendered for the plaintiff by the Court. J. M. Reifsnider represented the Turnpike Company, and E. O. Went the Stevenson Stone Plant Co. The petit jury was discharged last week.



He started up a 4 minute clip for his destination, and the streets being well filled with people on their way to church, would not interfere with his plans, but they gave Walker the right-of-way, as such an object as he was was not often seen on the public highway, but no one interfered with him, but left him go until he came to the railroad, where he was buckled up by officer Helm, with Walker saying "Helm let me go, Jesus has sent me to Union street to open up Union street church," but oh no, officers Helm and Jerome would not let a thing like that travel the streets, and they hand cuffed him and galled him to Sheriff Kemper's gloace, where he opened his cell instead.

TIME TABLE CHANGED.
Western Maryland Railway Trains Make Better Time.
The summer schedule of the Western Maryland Railway went into effect on Sunday last, about two weeks earlier than usual.

A number of the trains have been made faster, and an additional up train in the morning has been put on. The Union Bridge accommodation train has been restored after being taken off for over 2 years, which arrives here about noon.

TWO HORSES KILLED. MEMORIAL EXERCISES.

SAMUEL MILLER, THE OWNER, MAKES NARROW ESCAPE.
MR. FRANCIS SCOTT KEY SMITH DELIVERED ADDRESS.

Were Run Over by Freight Train at Freight Depot.
A Large Audience—Decorating of Graves.

Two horses owned by Samuel Miller near this city were killed by being run over by a freight train opposite of the W. M. R. freight depot on Tuesday morning. Mr. Miller was hauling earth from the Albion Hotel, which is being remodeled, and was on his way back to the building when the accident happened. A freight train was shifting around the yard and was coming up the main track with a draft of 8 or 9 cars in front of the engine, and Mr. Miller, at the same time was coming through the alley from N. L. Gorach Son Co., to cross over the track, and did not notice the train approaching on account of the view being obstructed by the number of buildings on the left, and there was no one on the car to give warning, which should have been. His horses were about the center of the track, when the front car struck the team between the front of the wagon and the horses, rolling the horses over and over until severing one through the center and killed the other, and at the same time throwing the car off of the track. Mr. Miller escaped by jumping or he too would have been killed.

The car was put back on the track and late in the afternoon the carcasses of the horses were removed by the railroad employes to a spot below Shriver's cannery factory, where they were buried.

Mr. Miller made his living by hauling and it is a severe blow to him.

DEATH'S HARVEST.
Well Known Residents And Others Who Have Passed Away.

Smith.
Howard T. Smith, a well-known retired farmer, died Tuesday afternoon at the home of his son-in-law, John E. Deeds, East Main street, aged about 75 years. He had been a leading member of Deer Park Methodist Church for nearly 60 years. He was the father of Charles H. Smith, the first American soldier killed in Cuba in the Spanish-American War. His wife died about two years ago. He is survived by the following children: Mrs. John E. Deeds, Mrs. Wm. Hollenback, Miss Martha A. Smith, of this city; Byron T. Smith, of Dayton, O.; Walter H. Smith, of Irlip, N. Y.; Geo. F. Smith, of Johnston, Pa.; and Mrs. Wm. E. Reicher, of Washington, D. C.

Funeral services took place yesterday afternoon at Deer Park M. Church, Rev. Warfield, of Westminster Seminary, officiating. Interment in the cemetery adjoining the church. The pallbearers were Elias N. Bays, Thomas Paynter, Ezra Little, John Baile, Henry Kootz and Joseph L. Mathias. James M. Stoner, funeral director.

Haines.
Mrs. Elizabeth J. Haines, 72 years old, widow of Evan Haines, died Monday of pneumonia at her home, near Linwood. She was suffering with the disease when her husband died, eight or nine days previously with the same malady, but was then apparently recovering. Her marriage she was Miss Elizabeth Jordan. Mr. and Mrs. Haines had lived together for more than fifty years in the house in which Mr. Haines was born and which had been in his family for nearly a century. They had no children. Mr. Haines was prominent and interested in public affairs and once represented this county in the House of Delegates.

Sarah R. Bowers, widow of the late Conrad Bowers, died at the residence of her son, William T. Bowers, near Linwood, of apoplexy on Friday morning, May 27, between the hours of 4 and 5 o'clock, in her 82d year. She was a member of St. John's Catholic Church.
