#### No Appeal to be Taken in the Bank Deposit Cases.

The following resolution was passed by the County Commissioners on October 23, 1911:—

Resolved, that no appeal be taken in the Bank Deposit Tax cases from the decision of the Circuit Court for Carroll County, and that all assessments of Bank Deposits be struck off the assessment books, and that any County taxes paid on any such assessments, shall be refunded to the taxpayer.

In assessing the Bank Deposits the Assessors followed the instructions of the State Tax Commissioner and the Attorney General, which was law, until decided otherwise by a Court; and the Court having decided that such deposits are not taxable, we have determined to stand by said decision and not take an appeal to the Court of Appeals.

## MORE REPUBLICAN FRAUDS FOUND.

### Twenty-Four Election Officials Presented.

Twenty-four election officials were presented by the grand jury, in Baltimore, following its recount of the Republican boxes of the Eleventh precinct of the Tenth ward, the Ninth of the Tenth ward, the Fourth of the Eighteenth ward.

The examination of these boxes disclosed evidence of wide irregularities in the count of the vote cast in the August primary. Although there was scarcely any opposition to the Republican organization since the recount, the boxes similar to those found in the Democratic boxes were unopened.

The election officials were charged with making a false return of the votes cast in the August primary.

An idea of how the anti-organization candidate on the Republican ticket for the State Central Committee was treated in the Eleventh precinct of the Sixteenth ward is shown from the recount of the precinct.

Mr. Diehl was given only three votes by the officials, while the jury found that 15 votes had been cast for him. The organization candidates were given many more votes by the officials than they really received; Mr. Gosnell was deprived of six votes by the grand jury. Mr. Kuebler was given six votes by the jurors, while Mr. McEvoy was given seven votes. The rest of the Republican candidates lost about the same number by the recount.

Mr. Diehl was neglected also in the Ninth precinct of the Tenth ward. The officials gave him two votes, while the jury added two more.

#### The Poultry Yard.

Lay in the winter's supply of road dust or sifted coal-ashes, as it will be needed for dust bars.

A load of gravel scattered around houses and coops would greatly contribute to the health of many a flock.

A hen will eat at least a bushel of corn a year if she can get it. Put aside the amount for each one, and send it each one gets her share.

Let dressed poultry of all kinds be cool clear through before offering it for sale; limp poultry does not sell so well as that which is good and stiff.

Secure a lot of leaves or other light litter for use, during cold weather, in making the hens exercise. Idle hens become mischievous and unhealthy stock.

Gather in the poultry that have been allowed to roost outdoors. The sooner they become accustomed to the house the better it will be for their health and improvement.

When a hen is determined to sit and "Ting, ducking and screaming 'shoo'." Fall with speckle, and she sits it through.

Just put thirteen fresh, fertile eggs under her feet and hatch occasionally, and let it go at that. It saves wear and tear on the nerves, and she gets over it better and more quickly; and if she hatches anything you are that much ahead.—From November Farm Journal.

## KILLED BY W. M. TRAIN

### JAMES E. KOLLER, OF ALESIA, MEETS DEATH ON TRACK NEAR HIS HOME.

A distressing accident occurred at 2 o'clock Sunday morning when James E. Koller was killed by a train near Alesia, this county. He and his twin brother, Allen Koller, 37 years of age and almost inseparable, had gone on a moon hunt that evening. They were on their way home without any game when they stepped on the railroad track. James was more than 100 yards ahead of his brother. Both were keeping a keen lookout for a stray coon or other animal which might cross their path before home was reached.

Allen heard the sound of an approaching locomotive and stepped aside in time. The train passed on and Allen stepped back on the track and resumed his journey, thinking his brother still walking ahead. Suddenly out of the dark tracks loomed a body. It was his brother—dead.

No house was within calling distance and Allen would not leave his brother alone. He watched by the mangled body all night until a track-walker found him at dawn.

The body was found between the rails with the left hand cut off and lying on the outside of the track, and the right leg on the outside of the opposite rail. The left leg was nearly cut off and there was a deep cut in his head.

The remains were handed over to undertaker Bergman, of Manchester, and carried to his place of business and prepared for burial. The mother of the boys having died a few years ago, James and his brother, Allen, erected a small house near Alesia and lived there together, securing work through the country. He is survived by two sisters, Mrs. Edw. Sherman, of Alesia, and Miss Jennie Koller, of Manchester; three brothers, Allen, of Alesia; William, of California; and George, a member of the Baltimore police force.

The funeral was held Tuesday morning. Interment was in St. Peter's cemetery, Rev. Keller, officiating.

#### Need of a New Pronoun.

Though there are about 400,000 words in the English language, and new ones added every year, we still lack one much-needed pronoun. Without it we cannot express a very simple idea without awkward circumlocution.

What is needed is a singular pronoun of common gender. A writer in a current magazine gives this sentence as an example of the need: "Everybody should have his or her purse with him or her when he or she travels."

Because there is no singular pronoun that will fill the need, thousands of fairly well-educated people are driven to the incorrect use of the plural: "Everybody should have their purse with them when they travel."

Others more properly but not more truthfully huddle along with the masculine pronoun alone, though all the travelers may be women: "Everybody should have his purse with him when he travels."

Forty years ago a Pennsylvania man suggested "thon" for this purpose: "Everybody should have thon purse with thon when thon travels."

But our noble language which eagerly accepts "skiddoo" or "swat" will have none of "thon." So we must continue to hear people say "Each of these children paid a dime for their ticket." Perhaps some of our bright readers can invent a better pronoun than "thon."—Current Events.

#### The Stork's Travels.

It has been ascertained, by marking storks with numbered rings, that these birds migrate from Europe to South Africa for the winter. A number of marked storks have been captured at various points in South Africa, and last spring one was caught near Jerusalem. It had come originally from Hungary, and was apparently on its homeward journey from South Africa, with four companions. This incident is regarded as showing that the storks, in passing between Europe and Africa, avoid crossing the Mediterranean sea, taking by preference the longer journey by land around its eastern end.—Harper's Weekly.
