WESTMINSTER ARRANGES FOR PROPER CELEBRATION OF FOURTH OF JULY.

Interesting Program Outlined by Committee—Contributions Solicited.

The committee appointed by the Mayor and City Council to co-operate with the clergymen of the city in arranging for the celebration of the Fourth of July in this city, met in the council chamber and arranged the following program:
All the public school children are requested to meet at the High School at half-past six o'clock on the evening of the Fourth, wearing red, white and blue sashes and carrying flags. Headed by the First Regiment Band they will march down Main street to the Roman Catholic School where the scholars of the past two years will be present. From this point they will march to Bond street and to the Park. Mr. John H. Mitten will act as marshal and be assisted by Miss Mary B. Shelman in placing the scholars in line.
On the park a stand will be erected for the united church choirs of the city which will lead in the singing of our national songs. Dr. Bonnotte will act as choir leader. Copies of the songs will be distributed with the purpose of having every one—young and old—take part in the singing. A short address will be delivered by the representative of our National Government in this city, our postmaster, Mr. H. Peyton Gorsuch. Prayer will be offered by Rev. Wm. H. Hetrick. A concert by the band will follow. A display of fire works for which a permit, as required by the ordinance of the Council, has been granted by the Mayor, will then be given.
Our citizens are requested to give their hearty co-operation in order that the birthday of our Nation may be fittingly commemorated, and that we may as a community express our grateful appreciation of the national blessings which have come to us from the lives and labors of our forefathers.

It is not organized to make money, but to give instruction and information. Its lecture courses cover all forms of knowledge—history, literature, art and sociology. During the last ten years lecture courses have been given in Frederick with a growing interest on the part of the citizens, also in the college of Notre Dame in Baltimore, in Elkton, Glyndon, in Hanover, Pa., as well as in other cities in Maryland and adjoining states. What has been done in other communities no larger than ours, can and ought to be done by us. Those who have this matter in charge feel justified in obligating themselves and making the necessary arrangements, providing 160 subscriptions of \$1.25 each are given. These subscriptions are for tickets for the course of six lectures and are transferable. But no one who attends the first lecture will miss any of the rest, if you are not called upon and desire to promote the success of this work leave your subscription at the First National Bank. It is necessary to take action now as the society is now arranging its series of lectures for the coming winter and many of its lecturers are in great demand.
The higher the level of life and the more intelligent and enlightened the citizenship, the more progressive and permanent the organized society becomes.
