### DESPONDENCY THE CAUSE.

### Paul E. Giggard Commits Suicide.

Paul Elmer Giggard, 22 years old, formerly of Cranberry, Md., committed suicide last Saturday night at Glenville, Pa., by sending a bullet from a rifle into his brain.

The young man had been suffering from melancholia since the death of his employer, E. D. Cooper, of Glenville, who was recently kicked in the head by a horse.

After Cooper's death Giggard, who had been suffering with diabetes, became despondent, and the death of Mr. Cooper deepened his mood and he became melancholy.

On Saturday morning he arose as usual and did his chores around the barn. About 10 o'clock he was seen to go to the house, and being missed a search for him. Upon going to his sleeping apartment on the second floor of the home, she found the body of the young man lying on the floor with a rifle beside him. Mrs. Cooper was frightened and called for her assistance.

A large hole in the middle of his forehead showed where the bullet had entered. He lay upon his back with his head in a pool of blood. It was evident to those who found it that the bullet had placed the rifle, which was broken in several parts, to his forehead, and holding the parts together with one hand had pulled the trigger with the other.

Giggard had always been sober and industrious, and displayed extraordinary loyalty toward his employer. He had been showing signs of a mental disorder recently and became very careless about his duties. His parents, Mr. and Mrs. Simon Giggard, of Cranberry, had the body brought home and funeral services were held at St. John's (Leister's) church on Tuesday afternoon. Rev. Hersh officiating. ## HEAD ON CRASH.

### ONE DEAD AND 3 INJURED IN W. M. R. WRECK.

### Scene of Collision Just Below Pen Mar Park—Misunderstanding of Orders Was the Cause.

As the result of a head-on collision between two freight trains on the Western Maryland railroad at Blue Mountain at 3.30 Wednesday morning Fireman J. D. Burbage, of Hagerstown, was killed and three were injured, as follows:

Engineman William A. Eckhart, Baltimore, arm broken and badly bruised.

Fireman C. L. Swartz, Hagerstown, cut about the body and badly shaken up.

The injured were given medical attention and then taken to the Washington County Hospital, Hagerstown.

The wreck occurred at the switch just east of Blue Mountain Station. Train 203, westbound, drawn by locomotive 620, pulling 27 cars, collided with eastbound train No. 204, drawn by locomotive 626. The westbound train was in charge of Conductor Isaac King and Engineman W. A. Eckhart. The eastbound train was in charge of Conductor J. W. Nichols and Engineman O. L. Hendrickson.

The collision occurred on the main track and both trains were running at a fair speed. Both locomotives, which rolled partly down an embankment, were badly broken.

Fireman Burbage's body, which was pinned under the engine, was not removed until shortly before noon. He was also being injured internally.

### Louis P. Slinguff Dead.

Louis P. Slinguff died Sunday night at his home, Avalon, adjoining the town of New Windsor, in his eighty-third year. Mr. Slinguff was born at Avalon, one of the finest farming estates in Carroll county, where he lived throughout his life. He took an active part in the politics of the county as a Democrat, seldom having been absent till long past middle age from the county conventions of the party and having often been connected with its county and State central committees. He served two terms as a judge of the Orphans' Court and was chief judge the second term. Subsequently he was appointed a member of the Board of School Commissioners.

His remains were interred on Wednesday in the Pipe Creek Cemetery of the Church of the Brethren, near Uniontown. His wife died many years ago. He is survived by two daughters and two sons—Mrs. James W. Beacham, of Avondale; Mrs. Thomas Stuffer, of New Windsor; Thomas C. Slinguff, at home, and Robert Lee Slinguff, of the Baltimore bar. He also leaves nine grandchildren and one sister, Mrs. Elizabeth Weaver, of New Windsor.

At the funeral Elder A. P. Snader officiated, assisted by Dr. James Freater. The pallbearers were: Thomas Slinguff, R. Lee Slinguff, T. J. Stouffer, J. W. Beacham, Sr., J. W. Beacham, Jr., and Slinguff Beacham, Harvey Bankard and Son, undertakers.

## M. P. CHURCH CELEBRATES DIAMOND JUBILEE.

### EX-PASTORS PRESENT—DR. J. W. HERING PREPARES HISTORY OF CHURCH FOR PAST 75 YEARS—LARGE RECEPTION MONDAY NIGHT.

What may be termed the diamond jubilee of the Methodist Protestant Church in this city, was celebrated this week by appropriate and interesting services, in which all the living ex-pastors of the church participated. Sunday morning, November 25, Dr. J. S. Bowers, D. D., president of the Maryland Annual Conference, delivered an impressive sermon, followed on Sunday afternoon by a platform service of song.

The most interesting feature of the four-days celebration was the reading by Dr. J. W. Hering on Sunday afternoon of the history of the church which he had carefully prepared from the incomplete records of the early times of the church and principally from his own recollections. Dr. Hering was especially qualified for this task as he has been a member of the Westminster church since 1851.

As early as 1828, near the time of the organization of the Methodist Protestant Church in this country, there was a nucleus of Methodist Protestantism in this city. In 1830 there was a "class" here numbering 21 persons, which had increased to 47 in 1832. The congregation became identified with the Maryland conference in 1837. The first church was built of brick on the lot on which the present church stands.

From 1837 to 1840 the congregation was a station. From 1840 to 1843 it was in the Baltimore circuit. From 1844 to 1871 it was one of the appointments of the Pipe Creek circuit, with two ministers. Since 1871 it has been a station, with one minister.

Emory Bennett, pastor of Centenary Methodist Episcopal Church; Rev. Wm. H. Hetrick, pastor of Grace Lutheran Church, and Rev. W. L. Seabrook, pastor of Trinity Lutheran Church. Refreshments consisting of ice cream, cake, nuts and coffee were served and the occasion was one of rare pleasure.

On Tuesday night a song service was held, with the sermon by Rev. Dr. Walter R. Graham, of Chestertown, Md. The celebration was concluded Wednesday night with a young people's rally, embracing Sunday school and Christian Endeavor Society, with an address by Rev. Luther F. Warner, of Salisbury, Md. Special music for the anniversary celebration had been prepared by the choir under the leadership of Miss Anna Shriver, organist.
