While the Judge was viewing the carnival. The car was left in front of the Renner Hotel, and when the Judge returned he discovered that it was gone.

Miss M. Belle Seiss, of Graceham, Md., who has been engaged in a millinery business in Biglerville, Adams county, for the past five years, has been seriously ill since March 9th, suffering from a very severe attack of rheumatism from which a general break-down of the nervous system has developed. For weeks she had to be kept perfectly quiet but now can enjoy the porch and lawn in an invalid's chair.

After loosing all recollections of Maurice Lowery, the murderer, for some time, and allowing the trail to cool down, it was again taken up on Wednesday by Sheriff Davis and his sleuths. Lowery was seen around Deep Run, it is said, and it was there that the officers made their search, but with the same result—nothing doing. As there are no colored people in that neighborhood, a colored man, answering Lowery's description called at Henry Zeigler's home and asked something to eat a few days before, it might be him. Deep Run is a good hiding place on account of its forests.

Thieves broke into the bandstand dressing rooms of the Royal Artillery Band at Riverview Park Tuesday afternoon and stole Director Salvatore Orrianno's best charcoal uniform, 16 garments and extensive list of instruments, four pairs of shoes and other necessary articles. Evidently they were interrupted in their operations, because six other instruments were found in a rear window conveniently accessible from outside. And they also evidently escaped by boat up or down the river, for no trace could be found of them, and their loot was not easily concealable. Instruments were secured in Baltimore and the musical program continued as usual.

George Arring, employed by the Maryland Flint Company at Glen Morris, was found Sunday morning along the tracks of the Western Maryland Railway in the Emory Grove yards with both feet crushed and one leg broken. He was also cut about the head and face. The discovery was made by Thomas Staubs, a freight engineer, who removed the unconscious man to Glyndon on his engine and summoned Dr. T. Rowe Price, physician for the railway company. After giving first aid Dr. Rowe had Arring removed to the Union Protestant Infirmary, where it was found necessary to remove one foot and part of the other. Sunday night the patient was reported as doing as well as could be expected. It is thought that he was struck by a passenger train about 1 o'clock Sunday morning and lay alongside the tracks four hours before being found. He was 29 years old and lived at Glen Morris.

Miss Mary G. Carroll has filed her answer in the Baltimore Orphans Court to the petition of her daughter, Mrs. John Philip Hill. The latter asked that the Court require Mrs. Carroll to probate in Baltimore the will of Mrs. Hill's grandmother, Mrs. Susan Howell Carroll, who died in New York on May 23 last. According to the answer, Mrs. Susan Howell Carroll owned in Baltimore certain property and had \$100,000 worth of securities in a box of the Safe Deposit and Trust Company standing in her name and the name of Susan Williams, a niece. All the securities are now in the possession of Miss Williams, with the concurrence of Mr. Hill, the answer states, although she has no right to or interest in them. The answer sets forth that Mrs. Carroll considers it her duty to file the will in Baltimore, and says she will do so as soon as it can be obtained from the files of the New York County Surrogate Court.

That Germany must eventually lose in the war now raging in Europe and that President Wilson is the one man in the world who can influence the nations engaged in the conflict to accept mediation was the opinion expressed Friday afternoon at the Hotel Belvedere, Baltimore, by Judge Ben B. Lindsey, of Denver, Col., whose ideas have revolutionized the world's way of dealing with juvenile offenders.

To improve the present standard the Board of County School Commissioners for Frederick county has abolished all the high schools of the county except those at Frederick, Middletown, Brunswick, Thurmont, New Market and Emmitsburg. Pupils will be furnished free transportation to these schools. The plan is to concentrate the high schools as much as possible and add additional grades.

"I have always had a desire to go to Europe, and while I will not go under the pleasant surroundings I had hoped to have some day, yet I am satisfied to do what I can for those who are so unfortunate as to fall in battle. I do not know where I am going or whether I shall have hospital or field work, but I will go anywhere I am sent," said Miss Lewis.
