

ORDER OF PUBLICATION

NO. 5261 EQUITY.
In the Circuit Court for Carroll County, sitting in Equity.

Mattie Crandell vs. Raymond A. Crandell, alias John R. Dexter, defendant.

The object of this suit is to procure a divorce a vinculo matrimonii of the plaintiff, Mattie Crandell, from the defendant, Raymond A. Crandell, alias John R. Dexter. The Bill of Complaint states:

First: That the plaintiff, Mattie Crandell, is a resident of Carroll County, Maryland, where she has resided nearly all her life and for more than two years past passed.

Second: That the defendant is a non resident of the State of Maryland and when last heard from was living in the State of New York.

Third: That the plaintiff and the defendant were married by the Reverend Frank M. Gibson, a minister of the Gospel, in Westminster, Maryland, on the 2nd of December, 1905, and lived together as man and wife until in the month of September, 1911, at which time the defendant abandoned and deserted the plaintiff and their two children, without any just cause or reason; and that he has not contributed anything to the support of this said wife and children since he abandoned them, as aforesaid.

Fourth: That the abandonment of the plaintiff by the defendant is deliberate and final; that their separation is beyond any reasonable expectation of a reconciliation and that the abandonment and desertion has continued uninterruptedly for more than three years before the filing of this bill of complaint.

Fifth: That two children were born of said marriage, both boys, namely: Brandon C. Crandell, age 14 years, and Edgar W. Crandell, age 8 years, both of whom live with the plaintiff and are supported by her.

Sixth: That the defendant was married to the plaintiff under the name, John R. Dexter although his correct name was Raymond A. Crandell, which the plaintiff did not know at the time of their marriage.

TO THE END THEREFORE:

First: That the defendant may be required to answer this Bill of Complaint.

Second: That the plaintiff may be divorced a vinculo matrimonii from the defendant.

Third: That the plaintiff may be awarded the custody of her said two children.

Fourth: That the plaintiff may have such other and further relief as her case may require.

It is thereupon this 9th day of November, 1920, by the Circuit Court for Carroll County, sitting in Equity, ordered that the plaintiff, by causing a copy of this order to be inserted in some newspaper published in Carroll County for four successive weeks before the 13th day of December, 1920; giving notice to Raymond A. Crandell, alias John R. Dexter, non resident defendant, of the objects and substance of this Bill, warning him to appear in this Court in person or by Solicitor on or before the 30th day of December, 1920, next, to show cause, if any he has, why a decree should not be passed as prayed.


