READY FOR CAMPAIGN

BOTH PARTIES HAVE COMPLETED PRE-ELECTION WORK—ISSUES AT THE FRONT—THE PASSING SHOW IN BALTIMORE.

Baltimore, Sept. 29th.—The political campaign in Maryland is ready for the fireworks. Democrats and Republicans have completed their tickets and formulated their State platforms. Further work is transferred to candidates, spellbinders, and campaign managers.

The outlook for big wads of cash is discouraging at the headquarters of both parties. Fear is expressed that with women voting legitimate expresses will be doubled with no corresponding increases in contributions. Indeed, there promises to be a dearth of money. Civil service in the State and city governments has put the campaign collector out of business. Office holders no longer fear the loss of their jobs if they do not respond to assessments by campaign chairman. Democrats will be heavy losers by this new order of things, political, since a majority of the City Hall employees in Baltimore are Democrats, while all of the State employees belong to that party.

Campaign "angels" in the Democratic camp are scarce this year, since no important office and no important issue are at stake. Former Senator Wm. P. Jackson, the most liberal contributor to the Republican fund, is still in Europe. If his interest in the fate of his party has not waned it ought to. As a slight return for his liberality in contributions and his party activities, he asked for a foreign diplomatic post. He is still unwarded. And what is more his favorite hunting ground, the Eastern Shore, has not received a single plum from the Republican National administration basket. Of course their pocket books are the best recommendations of Senator Weller and Senator France, to Republican favor, but as neither is a candidate this year each will hug his pocketbook tight, especially Senator France, as he will need every dollar he can command in his fight next year for another term. Senator Weller, careful business man that he is, will practice economy to make up for his expenditures last year when he was a candidate. Robert Garrett, Waldo Newcomer, Jacob Epstein, and other rich Republicans like rich Democrats, feel the burdens of income excess profits and other taxes.

A partial victory in the adoption of the plank for greater representation for Baltimore in the General Assembly, Mr. Rudy, of Carroll, who represented the county on the resolution committee, voted with the France-Broening combination for the increase which was adopted. In future Republican moves Mr. Rudy may, therefore, be looked upon as lined up with the City combination. Here is Senator Snader's chance. He can climb aboard the Weller band wagon. Mrs. Roby represented Carroll in the committee on credentials. No political significance was attached to this position.

Just as expected the Republicans offered no substitute for Governor Ritchie's plan to reorganize the State government by securing greater economy, greater cooperation. The reason for their failure is obvious. They could devise no substitute that would hold water. Instead they held the Democratic party responsible for creation of useless offices during the last twenty-five years. They conventionally forgot to mention the fact that during this period there were two Republican Governors, Messrs. Lowndes and Goldsborough. The record will show that Mr. Goldsborough signed the State Tax Commission, the Board of Prison Parole, and others. There is no memory of efforts on his part to abolish useless offices and to establish the budget system, which is a Democratic reform.

TABLES ARE TURNED.

REPUBLICANS ARE AT ODDS, WHILE DEMOCRATS ARE HARMONIOUS.

At last the tables are turned. It is a long time that does not averve. The Republicans are split into rival factions, while the Democrats are harmonious. Outwardly, at least, conditions in the two parties have been reversed during recent years. In Baltimore two rival Democratic leaders, Mahon and Kelly, have been fighting worse than cats and dogs. They are now working together. In several counties the old Smith and Lee feud has been smouldering for six years. The embers have been extinguished.

And rival Democrats in Baltimore and in several counties can get together and stay together, why cannot a few Democrats in Carroll county do likewise? If they don't the Democratic party will send the discordant elements to the waste heap.

The Republicans have split into two distinct factions, one headed by Senator Weller and one by Senator France and Mayor Broening. The differences of these two worthies have long been smouldering. Their first rupture came a few months ago when Senator France, without consulting his colleague, who had won his leadership spurs, was successful in his secret intrigue in supplanting Collector William P. Ryan, Democrat, with a Republican, Mr. Holzman, of Allegany county. If there was any reason for displacing Mr. Ryan one of the most capable Post Collectors Baltimore ever had, that reason has never been given. Even Congressman Zihlman, who lives in Mr. Holzman's home city, Cumberland, was not consulted.

Since Senator France got ahead of Senator Weller in this appointment the two gentlemen have drifted further apart. Their open break came at the Republican State Convention last week. Senator France drew the first blood by electing Geo. W. Cameron, a politician with his Republican neighbors in the 13th ward, divided on his local leadership, over Congressman John Philip Hill as chairman of the city committee. This would seem to be a blow to Major Hill's nomination next year.

In breaking away from Mr. Weller and in joining up with Mayor Broening Senator France is repairing his fences preparatory to his frantic struggle next for renomination and reelection. He seems to have foreseen that he could not look to Mr. Weller for aid. His radical views are wholly at variance with those of his colleague. Indeed, it is inconceivable that the people of Maryland, who are noted for their conservatism, should expose the extreme views of the Senior Senator on national and foreign questions.

It is breaking away from Mr. Weller and in joining up with Mayor Broening Senator France is repairing his fences preparatory to his frantic struggle next for renomination and reelection. CITY IN LEGISLATURE.

PROMISES BY DEMOCRATIC AND REPUBLICAN PLATFORMS.

Republicans, in their zeal to belittle the Democratic party, are proclaiming from the house tops that an increase for Baltimore's representation in the Legislature is the paramount issue in the State campaign. Furthermore, they declare that they have the only real live side of the question, which means, they say, that the Democrats have not a leg to stand on in the campaign. If the spellbinders of either party can arouse any enthusiasm on the question they will be squeezing blood out of a turnip. Here are the essential features of the two platforms on the question:

The Democratic platform declares: "The addition of two Senators and 12 Delegates, which is an increase of 50 per cent., and pledges our party to the submission to the people of a constitutional amendment therefor."

This would give Baltimore city a representation at Annapolis amounting to a total of six Senators and 36 Delegates.

The Democratic platform states, in the preamble of its plank, that Baltimore city's size "and population 'entitle it' to 'substantial increase,' and then 'declares for' the increase specified above. It adds: 'We urge our party to support this amendment at the polls.'

The Democratic plank fixes the representation at the figures 'outlined above—that is, it provides definitely for two additional districts, without suggesting any automatic method for either increasing or decreasing the size of Baltimore's delegation at Annapolis.

The Republican document declares for representation based on one Senator for each unit of population equal to the population of the most populous county in the State, and one delegate for each 20,000 of population. Under the 1920 census figures, this would give the city a total representation of nine Senators and 37 Delegates.

The Republican preamble "pledges support" to "such an increase as will be fair to the city and safeguard the rights of the less populous counties. On its specific proposition, it says that 'we propose that Baltimore city shall be entitled to' the increase mentioned.

The Republican platform provides for decreases in the Senate if the largest county, the basic unit for the city's representation, should 'grow faster,' proportionately, than the city, and for decrease in the House of the whole city population should decrease. Increases could come, in the Senate, if the largest county should not grow as fast, proportionately, as the city, or in the House, with each 10,000 of increase in the city's population each 10 years.

If both parties had pledged themselves to an increase in quality rather than quantity in the city's representation with General Assembly there would be real shouting in Baltimore for such a declaration.

A REVENUE FROM CULTIVATION FOR COUNTY BOYS.

Those County boys who cultivated plots of ground or carried out other farm projects as part of their school courses are to be congratulated on the showing which they made. According to the Supervisor of Vocational Education, there were 373 boys who earned nearly \$6,000 during the past summer as a result of this sort of work; but far more important, than the immediate cash income was the knowledge they gained of how to conduct farm work and the spirit of initiative that was developed through the accomplishment of a definite task whose successful outcome was due to their unaided efforts. Such boys as these, scattered through the counties of Maryland, have an excellent chance of becoming progressive and prosperous farmers, for they are being taught to use their brains as well as their hands. Agriculture is not simply manual labor. It demands the best thought that a farmer can give it, and the new generation which is being instructed in the modern methods of farming will do much to overcome the present difficulties which attach to that profession.—The Sun, September 27.

Of the above number of boys 29 are in Hampstead, 16 in Westminster, 9 in Mt. Airy, and 13 in Union Bridge, all Carroll County High Schools. The net income of these 67 boys from these agricultural projects amounted to \$124,602, during the past school year.

Democratic Women Organize

Will Endeavor To Have Women Voters To Register—Mr. Fenby Made President—Opera Well Filled—Other Officers Elected.

A great deal of interest was shown in the meeting held in the Opera House, in Westminster, last Monday night for the purpose of forming a Woman's Democratic Club for Carroll county. The meeting was called to order by Mr. Lester S. Patterson, a member of the State Central Committee, with Mr. Harry G. Berwager acting secretary. The singing of America was followed by a prayer by Dr. C. E. Forlines. The acting president appointed a committee on organization, consisting of Mrs. Carroll Albright, Mrs. Ada S. McDaniel, Mrs. Joseph B. Boyle, Mrs. J. W. Beacham, Mrs. Harold Frankforter, Miss Eleanor Birnie, Mrs. Thomas T. Brown, Mrs. John Klee, Mrs. Wade H. D. Warfield, Mrs. Wm. H. Vanderford, Mrs. Thomas Stauffer, Mrs. Nimrod T. Bennett, Miss Margaret Stem, Mrs. L. C. Stitley, Mrs. T. J. Coonan, Mrs. Michael Doyle, Miss Madeline Shriver. This committee reported the following plan of organization, which was adopted:

Sec. 1. The President shall appoint all committees (each of which shall consist of at least 4 members) that in her judgment are necessary or will be of aid in the work of the Club, and is directed to appoint the following committees, designating the chairman of each.

- A Membership Committee.
- A Registration and Polling Committee.
- A Speakers Committee.
- A Music and Decoration Committee.
- A Press Committee.

ARTICLE III.
The regular meetings of this organization shall be held on each Monday night during the campaign, beginning not later than the 1st Monday in October next; special meetings may be called by the President at any time, or in her absence by the President at any time, or in her absence by the Executive Committee.

ARTICLE IV.
Sec. 1. Any woman is qualified to be a member of this Club who is known to be a Democrat or any one in sympathy with the objects of this organization.

Sec. 2. In order to become a member of this organization the applicant for membership must sign the membership roll or authorize the Secretary to subscribe her name thereto.

Sec. 3. There shall be no fixed dues, the expenses will be met by voluntary contributions which should be handed to the Treasurer.

Mrs. Frank B. Fenby, of Woolery's district, was elected president; Mrs. C. E. Forlines, Vice-President at large; Mrs. Edward P. Brundige, secretary; Mrs. George A. Shriver, Treasurer. According to the plan of organization, there will be selected 14 vice-presidents, one from each district.

ARTICLE I.
The name of this organization shall be "The Woman's Democratic Club of Carroll County, Maryland."

Its object is to aid in registration and in giving the Democratic candidates a majority of the votes cast at the election to be held in November next.

ARTICLE II.
Sec. 1. The elective officers of this organization shall consist of a President, 1 Vice President at large, 14 Vice-Presidents, a secretary, a Treasurer, and an Executive Committee of 5 members.

Sec. 2. These officers and this committee shall perform the duties which usually fall upon like officers and a similar committee in other organizations, and they shall hold office until after the election or the abandonment of the club.
