### LEIGHTON TAYLOR IS SUED FOR KISS

YOUNG WOMAN CALLS HIM A "QUICK WORKER."

Washington, Feb. 22.—Leighton C. Taylor is a quick worker. Five minutes after I saw him for the first time he forcibly hugged and kissed me. That's why I am suing him for \$100,000.

This was the assertion of Mrs. Alma C. Smythe, of Alexandria, Va., a short distance from here in explanation of her suit, filed through an attorney in the supreme court of the District of Columbia, against the secretary of the late Senator Penrose.

Though she goes by the name "Mrs. Smythe," the plaintiff is not married. Her right name is Alma Schmidt, she admitted. She assumed the Mrs. Smythe in Cleveland, in 1918, she explained, because her German name had caused her to be annoyed during the war—at times, she said, she was investigated as a German spy.

Mrs. Smythe is attractive and admits she is "approximately thirty." She has red hair. The fact she is good looking, she says, is the cause of all her trouble.

The alleged action of Taylor occurred May 17, last, in an outer room of Senator Penrose's offices. Mrs. Smythe said. She had called to see the senator to get his endorsement for a project she previously had discussed with Postmaster General Will Hays, she said, and he told her to get the Pennsylvania senator's O. K.

"I had never seen Taylor before, he was an absolute stranger to me and I to him," said Mrs. Smythe. "I told him what I wanted and he said before I could see the senator I would have to 'play around' with him. And before five minutes had passed he grabbed me and kissed me despite my resistance.

"I ran out of the office and other times I returned to see the senator Taylor just laughed at me and reminded me I could not see Senator Penrose unless he said so. One time he invited me to his apartment in the Wardman Park Inn. I never did get to see the Senator and the last time I called Taylor ordered me out."

### SEVERAL COUNTIES AFTER BOND ISSUES.

### BIGGEST HOTEL IN WORLD IS PLANNED

Chicago, March 3.—Plans for the world's largest hotel, to contain 3000 guest rooms and to be built on Michigan boulevard at a cost of more than \$12,000,000, were announced here. It will be 25 stories high.

The announcement followed the sale of a block of land for \$2,500,000 on which the new hotel, to be known as the Stevens, will be built. The announcement was made by James W. Stevens, president of the La Salle Hotel Company.

According to Mr. Stevens, the hotel will contain a convention hall with a seating capacity of 4000, a banquet hall seating 1045 and a dining-room seating 1000.

One of the most notable innovations will be an aeroplane landing on the roof of the hotel more than a block long. The hotel is to be located just south of the Blackstone.

### BIG DEER ATTENDS BURIAL OF PENNSYLVANIA FARMER

Clearfield, Pa., Feb. 27.—"Old Baldy," a buck deer, known to woodsmen, hunters and farmers in Northwestern Pennsylvania as the most elusive of all big game animals, and at the same time one of the most docile in the closed season, surprised residents of Hillsdale yesterday by joining the funeral procession of William Owens, a farmer, soon after the cortege had left the house.

"Old Baldy" had an acquaintance of several years with Mr. Owens and they had frequently met in the fields and forest. Owens on more than one occasion had patted the buck's sleek sides.

"Old Baldy" came out of the forest a short distance below the Owens homestead and, keeping a short distance behind the procession, followed it to Hillcrest Cemetery. Mourners had a fine view of the big buck as he strode along with never a glance to the left or right, but straight to the cemetery, stopping near the gates, where he stood and watched the services at the grave.

Apparently satisfied that his old friend had come beyond recall, "Old Baldy" gave a loud snort, threw up his head and dashed into nearby woods as the singing at the grave ceased.

### 38 FIRES IN NIGHT IN HAUNTED HOUSE

### FLAME GHOST CAUSES NOVA SCOTIAN COUPLE TO QUIT OLD HOME

Halifax, N. S., Feb. 22.—The isolated farming community of Antigonish, in Northeastern Nova Scotia, has a haunted house in which 38 mysterious fires followed one another in strange procession during one night.

On several other nights more fires occurred, starting in walls, under eaves and in furniture. Neighbors, and in one instance a police detective, hearing the stories the aged farmer, Alexander MacDonald, his wife and their adopted daughter, Mary Allen, recounted of their adventures with the nocturnal visitor, kept watch and testified to the "flame ghost."

So intense is the interest that a reward of \$200 has been offered for proof that the baffling manifestations are not of supernatural origin. The aged couple and their adopted daughter, who lived in the homestead for 20 years, became so terrified that they have abandoned it.

The first signs of the unnatural were in 1916, when cattle and horses, left securely tied in the adjoining barn, were occasionally found untied and wandering out of their stalls in the morning.

### PATRONS ASKED TO CO-OPERATE IN EVERY WAY POSSIBLE.

The Postoffice Department has asked weekly papers to publish the following article, in order that the Rural Delivery service of the country may be improved:

"By direction of the Postoffice Department, postmasters throughout the country have recently made an inspection of the rural routes from their offices. The purpose was that they might ascertain by personal observation and make report whether the roads used were in good condition for travel, the routes well arranged, boxes properly erected, so as to be easily reached by the carriers without difficulty and without obstructing travel, the carriers serving their routes as officially prescribed, the schedule observed, and whether the families served were satisfied with the service rendered, or there were improvements which could be suggested in the interest of the patrons of the Department.

It became necessary, in connection with the inspections, to request many patrons to take action to the end that their boxes might conform with the regulations as to kind, condition, location, or height, and in having the name of the owner plainly printed on them. Also, to bring to the attention of road overseers or other responsible persons the need for improvement in roads or repair or construction of culverts or bridges.

It is the desire of the Department and its purpose, to provide adequate and convenient service, so far as may be possible, to all persons residing in rural communities, but this end can not be attained without the full co-operation of the patrons in the efforts of postmasters and carriers to serve them promptly, regularly and satisfactorily.

Whatever facilitates the work of the carrier is of direct benefit to the patrons, for the greater the ease and speed with which a carrier may cover his route the earlier and better the service afforded.

So, patrons of rural delivery can greatly help themselves by helping their carrier, seeing to it that roads are kept in good condition and promptly opened after storms, by keeping the approaches to their boxes clear, and by promptly and willingly correcting any irregularities affecting their boxes when asked to do so.

Another great assistance that patrons can render carriers is by keeping themselves supplied with and using stamps instead of placing un-stamped mail, with money for the purchase of the required postage in the boxes. This delays the carrier and sometimes imposes a great hardship on him, especially in cold or stormy weather. If preferred, stamped envelopes, either printed or plain, may be obtained from the carrier, are of good quality, and cost but little more than the value of the stamps upon them, and are redeemable at the value of the stamps if damaged, but returned in a practically whole condition. If necessary to place money in a box, it should be put in a coin-holding receptacle or be properly wrapped so as to be easily picked up by the carrier.

Money for the purchase of money orders should not be left in the boxes, but should be handed to the carrier and a receipt obtained.
