

PROPOSED AMENDMENTS TO THE CONSTITUTION SUBMITTED TO THE CITIZENS OF THE COMMONWEALTH FOR THEIR APPROVAL OR REJECTION BY THE GENERAL ASSEMBLY AT THE COMMENCEMENT OF PENNSYLVANIA.

Number One. A JOINT RESOLUTION. Proposing an amendment to section one, article eight of the Constitution of Pennsylvania.

Section 1. Every male citizen twenty-one years of age, possessing the following qualifications, shall be entitled to vote at all elections, subject, however, to such laws requiring the registration of voters as may be enacted by the General Assembly.

First. He shall have been a citizen of the United States at least one month. Second. He shall have resided in the State one year immediately preceding the election.

Fourth. If twenty-two years of age and upwards, he shall have paid within two years a State or county tax, which shall have been assessed at least two months and paid at least one month before the election.

Section 1. Every citizen, male or female, of twenty-one years of age, possessing the following qualifications, shall be entitled to vote at all elections, subject, however, to such laws requiring the registration of voters as may be enacted by the General Assembly.

First. He or she shall have been a citizen of the United States at least one month. Second. He or she shall have resided in the election district where he or she shall offer to vote at least two months immediately preceding the election.

Fourth. If twenty-two years of age and upwards, he shall have paid within two years a State or county tax, which shall have been assessed at least two months and paid at least one month before the election.

Number Three. A JOINT RESOLUTION. Proposing an amendment to section twenty-one of article three of the Constitution of Pennsylvania.

Section 1. Be it resolved by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That the following amendment to the Constitution of the Commonwealth be, and the same is hereby proposed, in accordance with the eighteenth article thereof.

Amend section twenty-one, article three of the Constitution of the Commonwealth of Pennsylvania, which reads as follows: "No act of the General Assembly shall be valid for injuries resulting in death, or for injuries to persons or property, and in case of death from such injuries, the right of action shall survive, and the General Assembly shall prescribe for such injuries the manner in which they shall be prosecuted."

The General Assembly may enact laws requiring the payment by employers of reasonable compensation for injuries to employees arising in the course of their employment, and for occupational diseases of employees, whether or not such injuries or diseases were caused by the negligence or fault of employer of employee, and fixing the basis of ascertainment of such compensation, and providing special or general remedies for the collection of such compensation.

The General Assembly may limit the amount to be recovered for injuries resulting in death, or for injuries to persons or property, and in case of death from such injuries, the right of action shall survive, and the General Assembly shall prescribe for such injuries the manner in which they shall be prosecuted."

Be it resolved by the Senate and House of Representatives of the Commonwealth of Pennsylvania in General Assembly met, That article four of the Constitution of Pennsylvania shall be amended by adding thereto section twenty-three, which shall read as follows: "The office of Secretary of Internal Affairs be, and the same is hereby abolished, and the powers and duties now vested in, or appertaining to, or belonging to, that branch of the executive department of this State, shall be transferred to such other departments, offices, or officers of the State, as the General Assembly may direct by law."

Dealing with the question of Great Britain's obligations, Sir Edward said: "Up to yesterday I had given no promise of more than diplomatic support. I was asked at the time of the Algeiras crisis if we would give armed support and I said I could promise nothing to any foreign power unless it had the support of public opinion."

"I gave no promise, but I told both the French and German ambassadors that if war was forced on France public opinion in the British Isles would rally to France."

"This part of the speech was received with loud cheers," Sir Edward said. "His Imperial Majesty, the Kaiser, has by imperial decree ordered the entire mobilization of all the forces comprising the German Emperor's army. And this decree is extended to all of the reserves, as follows: "The land and sea reserves of the First and Second Corps."
