BLAYDES AWARD IS UPHELD TODAY

Local Compensation Case Is Closed by an Opinion From Mackey

Thomas J. Blaydes of 1214 Apple street, will receive \$53.33 workmen's compensation for disability from May 9 to July 26, 1916, as a result of an accident sustained while at work at the Harrisburg Bag and Box Company. Blaydes who sustained two fractured ribs, by a fall from a stepladder, while cleaning the office at the plant of the Harrisburg Bag and Box Company was also awarded \$10 for medical attention. The costs, amounting to \$7.50 are also to be paid by the

company. Harry A. Mackey, chairman of the Workmen's Compensation Board, in an opinion to-day affirmed the award of E. K. Saylor, Workmen's Compensation Referee for this district who allowed the compensation above outlined to the employee.

Mr. Saylor is holding a hearing at the Central Hotel, Harrisburg, to-day on the claim of Niles Balsh against James Williams for disability following an accident September 1, which Balsh claims will totally disable him for probably seven months. A tree cut down by Balsh, while employed by Williams, fell upon Balsh fracturing several ribs and tearing tissues from the lungs.

To-morrow Referee Saylor will hold a hearing at Waynesboro on the claim filed by Mrs. Hattie Kirkpatrick of Scotland, against the Emerson-Brantingham Company of Waynesboro. Mrs. Kirkpatrick claims compensation for herself and three children. Her husband, John K. Kirkpatrick, died on August 23 as a result, it is alleged, of injuries received while at work in the defendant company's shops on July 25.

DECLARES HUGHES IS SURE TO WIN

Ex-Chairman of G. O. P. National Committee Sees 308 Electoral Votes

New York, Nov. 1.—Frank H. Hitchcock, formerly chairman of the Republican National Committee and a member of the advisory committee for the present campaign, has issued a prediction as to the outcome of the election, basing his conclusions on reports received from experienced political leaders in each one of the States concerned. The statement is as follows:

Hughes will be elected on November 7. He will carry the following States, having an aggregate electoral vote of 305, or 42 in excess of the required 268:

CLAIMANT MUST OBEY THE DOCTOR

Compensation Board Puts Out an Interesting State-Wide Ruling

The State Compensation Board, in an opinion rendered to-day in the case of John Higgins, Tamaqua, against the Lehigh Coal and Navigation Company, upheld Referee Paul W. Houck in his refusal to grant compensation for a full period of disability because the claimant did not remain under care of physicians the entire time. Higgins was injured about an eye in a mine and failed to remain under care of a physician, absenting himself for some days. As a result his eye had to be removed. The opinion states: "The fact that the eye had to be removed was, we think, due entirely to the exposure incurred by the claimant himself when he took the matter into his own hands." The compensation was allowed for eleven weeks and claimed for 125 weeks.

The State Compensation Board in a decision by Commissioner Leech in the case of Moore Getty vs. William Henderson & Co., Philadelphia, refuses to allow a claim and makes the following ruling: "An employee injured on the premises occupied by or under the control of the employer during the lunch hour or when on his way home or at any time or place when not actually engaged in furthering the employer's business or affairs, is not entitled to compensation unless the accident was caused by the condition of the premises or the operation of the employer's business."

In the case of Maline vs. Delaware and Hudson Company, Scranton, the opinion making the ruling that statements by witnesses for the claimant were based on statements "made after the lapse of such a period from the time the accident is alleged to have happened as to be clearly hearsay. We have held that such evidence without satisfactory corroboration will not be made by us the basis for a legal conclusion fixing liability upon a defendant."
