## \$1,000,000 IN LIBERTY BONDS

### Campaign Launched at Carlisle For Big Sale Throughout Cumberland County

Carlisle, Pa., June 4.—A campaign to place \$1,000,000 in Liberty Loan bonds in this county was formally launched today by a central committee composed of prominent county bankers. Manufacturers, professional men, wage-earners and all classes will be asked to subscribe. Banks will loan money at three and one-half per cent. for nine months to prospective purchasers, and bond clubs will be formed.

## WOMAN STOPS POLE PLANTING

### Mrs. Alice Starr Hauck, of Mechanicsburg, Blocks Work Because Not Consulted

Mechanicsburg, Pa., June 4.—Because of a difference of opinion between linemen of the United Telephone Company and Mrs. Alice Starr Hauck, two new trees have been planted in front of property owned by the latter on the corner of South Market and East Coover streets.

When Mrs. Hauck learned that a telephone pole was to be placed on the grass plot between the sidewalk and curb, displacing one in the gutter, and that the hole was already dug without consulting her, she appeared on the scene at 4 o'clock on Saturday morning with a shovel and proceeded to fill up the hole. In the meantime she returned to her work, she awaited the return of the workman, standing by the tree. As nothing could be accomplished, the linemen returned to their work after dinner, but Mrs. Hauck was ahead of them. Thinking to put "one over" on her, a man ran up the pole with the wire to be used as a support, according to Mrs. Hauck, when she ran out and caught hold of it. Wrapping the wire around her, she laughing told the men that they would either have to pull her up or suspend her. Then she told her son to bring her a rocking chair, a newspaper and her glasses. After which she placidly sat in the chair, taking the wire from about her body, and twisting it about the chair arms, and continued the remainder of the afternoon, saying she was having a fine rest, just what she needed. The man on the other end of the wire could not say as much, however, as he was not so much in a position to rest. When his fellow-workmen re-entrusted, Mrs. Hauck suggested that he come down a foot and slacken the wire and he would find it easier.

In the meantime a crowd of people gathered on the scene, where she was holding up a force of workmen and two horses, and various suggestions were offered. Finally when quitting time came, and the men clambered into the wagon and drove away, Mrs. Hauck also went into the house. In a trice the men reappeared, but again the woman was ahead and before the pole could be set another tree was planted. She told the men that if they came at 10 o'clock that night, they would find her still there.

Mrs. Hauck, who is a prominent public-spirited citizen, deprecates the publicity given the affair and says she would have preferred to have been avoided had she been consulted previously in regard to it. Also placing the pole in position where the hole was dug, injures the pole and trees, and is only about eight feet from another pole.

He regained consciousness just before a car was placed at his disposal and was taken to his home in West Main street.
