President J. G. NEWKAMP, upon taking the chair, called for the reports. And, it being suggested that the meeting was called for a special purpose, the regular order of business was dispensed with.

Dr. NEWKAMP presented a report in regard to the Cholera, recommending certain measures to be adopted.

Dr. NEWKAMP said there was no doubt that the cholera has broken out in the suburbs of the city, and it was necessary to adopt precautionary measures. He thought that a conference should be had with the Board of Aldermen and Common Council and prompt measures taken.

Dr. WINSTON stated that he had visited an old negro man of steady habits, whom he had known for years, and found him in a collapsed state, and pulseless. He lived in a shanty, in the field beyond the Penitentiary. In a cluster of buildings, near those, were three deaths to night before.

Dr. MADSEN stated that he went with his brother to see a case on the Harding Pike, just beyond the Cumberland Hospital. The man went to bed well, and was taken with the cholera at 12 o'clock. He had eaten freely of water-melons. He was a hearty Irishman, and sober, steady and industrious. He went with Dr. WINSTON to see another case, and while there heard of two more deaths by the same disease. Dr. WINSTON's patient will probably die. These people live in small rooms, and near water from a spring that runs near the cabin. The total number of deaths he reported were four.

MUNICIPAL. BOARD OF COMMON COUNCIL. FRIDAY, AUG. 31st, 1906.—The Board met pursuant to the following communication from the Mayor: Mayor's Office, Nashville, Aug. 30th, 1906.—Confidentially, I have deemed it proper to convene you this evening to consider matters which require immediate attention in regard to the financial condition of the corporation, and especially in reference to the health of the city. I recommend the adoption of such measures as may be suggested by the Board of Health, in view of facts which have come to the knowledge of the authorities during the day, and in view of the fact that it is highly in our interest to secure the public health.

The Board was called to order, and President Corbin took the chair. The above communication was presented and received. The following petition was presented: To His Honor the Mayor and City Council: We respectfully solicit your aid and cooperation in organizing a hospital for the poor unfortunate sick of this city.

All we now ask of your honorable body is to make a building for a single year. Before the expiration of that year we expect to have a hospital building of our own on College Hill.

We propose to have built furnished up to equip the establishment, and to give our services free to all charity patients. On motion of Mr. DUNCAN, the resolution was so amended as to give the Mayor a full discretion in the matter, and was passed.
