TURKEY WOULD BRIDGE GULF BETWEEN CONTINENTS. Constantinople Dispatch Tells of Bill to Finance Inquiry as to Bridge and Tunnel.

AMSTERDAM, Feb. 4.—The Turkish government, according to a Constantinople dispatch to the Vossische Zeitung, has introduced a bill in parliament asking for an appropriation to investigate the feasibility of the construction of a bridge or tunnel connecting Europe with Asia.

There are two straits separating Europe from Asia Minor, which might be used in a bridge or tunnel project. They are the Bosphorus at the entrance to the Black Sea, and the Dardanelles, at the entrance to the Mediterranean.
