Campbell and United States District Attorney W. P. McGinnis, of Muskogee. The men are John Culver, Ed Cobb, W. F. Carden, Carl Johns and William Rogers. All have been arrested.

ARMY SERVICE CORPS MEN PUZZLE CIVILIANS AND OTHERS

Marching to the time of "over there" 500 soldiers of an entirely new sort paraded the streets of Chattanooga this afternoon. The new men were conspicuous for green hat cords, and nobody knew what it betokened. Even the regular soldiers in the streets were at a loss to explain the mystery, and a phone message to some of the officers at Oglethorpe brought it softly—evoked no information.

For awhile the populace thought they must be starting at a brigade from the land of shamrock and shillelahs, but it turned out they were men of the army service corps.

General duty around camp falls to the lot of the soldiers with the green hat cord. They are sabbie boys, fetch and carry and clean, and made themselves at home with any old job that comes along.

The mysterious strangers were a regiment of these men passing through Chattanooga.

MILITARY SPIRIT PERVADES COUNTRY

Somewhere in France Where Music of Airplanes Mingles With Buzz of Motorcycles.

Keith J. Harris, son of Mr. and Mrs. T. J. Harris, of 130 Mitchell avenue, is making good with the headquarters company of the Thirtieth division, American expeditionary forces, "over there." After having been transferred from the adjutant's office to a section of the department of the chief of staff, his latest recognition has come in the form of a promotion to battalion sergeant-major. His parents have received an interest-

ing letter from him, in which he gives an account of his experiences and life "somewhere in France." "All the towns we have passed through are far sabbie dead as commercial activities," he wrote. "Everybody and everything shows evidence of the war. In most of these towns and villages there are more soldiers than civilians. We see soldiers of all the allied armies—the English, French, Scotch, Belgians and Americans. I have noticed very few boys or men eligible for the army who are not in uniform. Of course, I may see something different if I ever go through any of the large cities.

"Most of the houses in the villages are made of either brick, plaster or stone, and barns, etc., are of clay and straw. The country itself is pretty. The people take extra good care of their farms and gardens, and all available space is used for planting or pasturing. I have not yet seen any forests like there are in the states. Of course, there are clumps of trees, but these look as if they are trimmed and taken care of.

"We were paid off a few days ago in French money, and I drew about 165 ten-franc notes. Seems like a lot of money compared with the three or four five and ten-dollar American notes I used to draw. We can spend American money here. Our location enables us to buy milk from the people here, and I drink it two and three times a day. Some of the fellows say I am getting fat, but I think I look that way because I had my hair cut close.

"I have not yet had any rain, and on account of the heavy traffic the roads are sure dusty. It has been cloudy several times, but has not yet gone far enough to rain.

"I suppose you are expecting to hear some news of the war direct from me, but you folks possibly know as much as I do about the drives, etc., as all I can learn is by reading the newspapers and bulletins. Airships buzzing overhead, motorcycles and automobiles speeding by, the passing of heavily-loaded trucks and the tramp, tramp of soldiers are most familiar. Bicycles are more used over here than in America. They are used both by inhabitants and armies. The bicycles look like what is termed an 'ice wagon,' but are pretty good.

"I have read an account of the raid around New York by the German submarines, and would like to know what some of the people think about it. I suppose some who used to say 'Wait until Germany comes over here and then we'll be time to fight,' now have nothing else like that to say."

BERRY TELLS VIVID TALE OF HUN ATROCITIES

Labor Leader Back From Battlefield Urges Top-Notch Patriotism.

George L. Berry, president of International Pressmen and Assistants' union, who just returned from an investigation of labor conditions in the allied countries in behalf of the American government, told last night at the Pilgrim Congregational church some of his experiences at the front. During his tour Mr. Berry spent two days with Gen. Pershing, in England he was received by Lloyd George, while in France he visited Clemenceau. Further, he held conferences and made speeches in every major manufacturing town in England.

In his visit to the front line trenches Mr. Berry related, as an eye witness, seeing allied soldiers who had their ears cut off, their tongues cut out and all the different barbarities inflicted by the Germans, which America found so very difficult to believe for years. A mere roster of the things this representative of the government saw is sickening—the ripping up of pregnant women, crucifixion of allied soldiers, maiming, mangling and mashing. The tale he brought to his audience sounded more like delirium or the fantasies of madness than sober recital of facts. Citizens of this country still do not comprehend these things happen.

Mr. Berry was at Verdun and Rheims in the height of the last great offensive. The Kaiser made two strikes at the speaker before he reached home. In London the speaker saw the great-




