During the night she went down into the kitchen and kindled a fire of wood and shavings on the middle of the floor, with the evident design of burning herself to death, as was discovered by the Superintendent, who had been awakened by the smell of fire, the woman stood in the center of the pyre, her clothing all ablaze. He speedily removed her from her terrible position, but not before she had received fatal injuries, from which she died a few hours later. The fire, communicated to the woodwork of the building, and was with difficulty extinguished. There were in the institution at the time sixty-five children and eight grown people. It was ascertained that the woman was partially insane, and had wandered from the house of her brother on Forty-first Street. She is said to be the wife of Morris Kerstein, of Ashley, Ill., and has a brother and sister living at Marion, Ill.

A SINGULAR and unaccountable crime is reported from Lapeer Village, Mich. While people were at church, Mrs. Bernard went to the house of Rev. E. Curtis, the Baptist pastor, attended his wife, an old lady about 65, who lay down, poured gasoline over her clothing and set it on fire. The poor woman was so shockingly burned that she lived but a few hours. Mrs. Bernard is about 60 years old, the wife of a prominent citizen, and has been conspicuous in her relations to church affairs. Some think she was crazed by religious excitement. She was arrested.

JOSEPH DEROOBE, a French Canadian miner, was hanged by a vigilance committee near Bodie, Cal. He had shot and killed Thomas Treloar, because the latter objected to Deroobe dancing with his wife. A "blow-off" explosion occurred at the "Army in Salvo," England, which is charged to Penzance. One boy had died from injuries received.

A RAILWAY accident at Wakefield, Yorkshire, England, caused the death of seven persons. The injured number thirty or forty.

J. PHILIP KRIEGER, the defuncting Cashier of the defunct Broadway Savings Bank, St. Louis, committed suicide on the 17th. He was on trial for embezzlement.

The widow girl, the only survivor of the recent Oakbrook (Wis.) tragedy, has so far recovered as to be able to make a statement. She says her father killed her mother with a club, supposed to have killed her, and then fired the house and barn, in which he perished. There is little doubt that Yankov was hanged.

CAPTAIN GEORGE W. CHILSON, United States Army, committed suicide on the 12th, at Fort Daness, Tex. Cause unknown. He was master of Michigan.

A WOMAN's triple murder was committed during the night of the 17th, near Plain City, in Madison County, O., the victim being Mrs. Matilda Best, a colored woman, her daughter, aged 22, and adopted son, aged 14, named Charles Best. All three had their brains beaten out with a club. Information of the crime was first obtained from a colored man named Robert Garret, who came into town and reported the affair in an excited manner. He was at once suspected of being the murderer and placed under arrest. Garret's testimony worked on the best place, and three months ago left in anger because the widow would not let him take the blame.
