

MR. WARWICK'S WILL

DECISION OF THE SUPREME COURT IN THIS INTERESTING CASE.

The Paper Produced Not Authenticated According to Law, and Therefore Null and Void.

Mention has been made in the Dispatch that the Supreme Court of Appeals on Thursday in an opinion prepared and read by Judge B. W. Lacy affirmed the judgment of the lower court in the case of Warwick vs. Warwick.

It was a matter of a will, or an alleged will, made by Abraham Warwick, Jr., disposing of a fortune of \$25,000, and had been held good, deeded and property had been sold and conveyed during her life, and at her death to his nearest of kin.

The question at issue was whether an endorsement on the paper could be construed as a sufficient signature.

The testator was about forty-five years of age at the time he died. He resided on the north side of the Brook turnpike and the Brook separated his farm from that of Mr. John Sinar.
