NICARAGUA CANAL MEASURE.

This is in Danger of Defeat at the Hands of the Senate in Washington.

WASHINGTON, D. C., December 31.—(Special.)—Not only is it still regarded as uncertain what the fate of the pending currency bill will be, but it is doubtful if a majority of the Virginia and North Carolina members in the House have fully made up their minds how they will vote.

The managers of the proposition, however, seem to think they will have the support of most of the congressmen from these two States; but if they are right or thought they will have to present a different bill from that first brought out by the committee.

There is a feeling among the average Democrat that something must be done this session to relieve the Treasury, but a Virginia congressman who has looked into the situation carefully is positive nothing can be done as long as the House is opposed to the Carlele plan.

Gov. Governor Gates, of Alabama, gave it out yesterday that there would be no financial legislation, and he discovered also that the Nicaragua canal bill was in great danger of defeat.

The Richmond people who are so anxious for the canal bill shall pass are probably doomed to disappointment unless a change in sentiment occurs soon in the Senate, several of the members of the House talk as if they will vote against the canal bill if it is taken up in that body this session.
