While the papers were being taken out, a riotous crowd had a good supply of ammunition.

Mr. Cross took a row-boat and started for the yacht. On arriving there he went aboard, and was suddenly confronted by the "Haller" who was backed by the dog, whose growls at the Deputy Marshal's appearance had given warning. The woman protested she was not armed, and being served, and suddenly showed a loaded revolver under the astonished Deputy Marshal's eyes. He ordered her to be ordered him ashore. He obeyed, and later swore out a warrant against the woman for resisting arrest.
