THE SOUTHERN SCHEDULE.

The letter from Chase City published in the Dispatch yesterday morning truly says that with respect to morning mails out of Richmond the people of that section of the country are hardly any better off than they were in stage-coach days.

The earliest daytime train leaving here over the Richmond and Danville Division of the Southern road starts at 12 o'clock and 1 minute P. M. Think of that! By that hour the Southern Company has taken the morning papers from Washington city and from Atlanta, Ga., and distributed them over hundreds, if not over thousands, of miles of territory.

While Richmond has not one single train to carry out a morning paper, Washington has one that is highly serviceable and Atlanta has three. The Southern cannot arrange to give us one single morning train, but it finds it very convenient to give Atlanta three, leaving between the hours of 5:30 and 7:30.

Now, really, it is asking too much that the capital of Virginia, and her largest city, and the Southern's great business contributor should ask for the recognition of a schedule which is so obviously out of date, unfair, and injurious?

What is wanted is not a train leaving Richmond in the darkness of the night, carrying out a fragment of a morning paper labelled "first edition"—printed at midnight—but a train which will give to our country friends, between Richmond and Danville at least, a real, bona-fide, full-fledged morning paper.

We need not go into any argument to convince intelligent people that where our papers go our letters can go, and that the closer the means of intercommunication between buyer and seller the more prosperous both will be. It is lamentable that the business-men of Richmond have not been more active in working for this reform; but we doubt not that they will begin to take some interest in it.

The action of the Chesapeake and Ohio Railway Company and that of the Seaboard Railway Company in providing us with reasonably early outgoing morning trains has inspired them with hope—hearthened them, as it were.

The Southern Railway Company cannot justify itself in its present position, and we sincerely believe that after full discussion of the subject they will yield to the public demands for a satisfactory morning train out of Richmond. To aid in effecting this much-to-be-desired reform, we ask the co-operation of our country friends in all that widespread territory now deprived of such train facilities as the Southern Company give freely and liberally to the rural communities of Georgia.

Be it remembered that the country people on the line of the Richmond and Danville railroad, in the respects we have mentioned, are worse served than any other community in this Commonwealth. Are they content that it should be so? or do they wish to have as good mail facilities as are accorded other country people living as near as they do to a city of 90,000 or 100,000 inhabitants?

THE GILLIGAN CASE.

Further Proceedings Postponed. SUFFOLK, Va., June 26.—(Special.) Judge Atkinson convened court this afternoon at Isle of Wight Courthouse to hear further argument on the question of a new trial for Gilligan. On motion of the defence the matter was continued till next Monday. Mr. Holland was present for the Commonwealth, and Mr. Edwards for Gilligan. The prisoner will not be taken to Petersburg till after next Monday.

Lexington Notes. LEXINGTON, Va., June 26.—(Special.) Hon. William L. Wilson, president of Washington and Lee University, and Professor Harry St. G. Tucker, dean of the law faculty of the university, are at Capon Springs, in attendance upon the third annual conference on Christian education in the South, which convened there to-day, and will continue in session for three days.

Professor James Lewis Howe, of Washington and Lee University, the vice-president of the chemistry section of the American Association for Advancement of Science, and Professor LeConte Stevens, of the university, are in New York attending the annual session of the association this week. Professor Howe delivered an address before that body on Monday evening.

The funeral of Mr. Samuel C. Lindsay took place from his home, on Timber Ridge, Monday afternoon, and interment followed in the Lexington Cemetery. Rev. T. A. Hall officiated. Mr. Lindsay was aged about 67 years, and was a Confederate veteran, a member of Company G, Thirty-first Virginia Infantry. He is survived by his wife and six children.

State Medical Board. LYNCHBURG, Va., June 26.—(Special.) The State Medical Board is in session in this city. One hundred and twenty applicants for admission to practice in the State are being examined, and the examinations will not close until Thursday evening. The board has adopted regulations to conform with the recent acts of the Legislature, permitting the board, at its option, to receive certificates from other States, and placing violations of the medical laws in the hands of juries.
