TOBACCO REBATE AGREED ON. Other Sunday Civil Bill Items--\$75,000 for Richmond Building.

WASHINGTON, D. C., June 20--The conference of the House and Senate today reached a partial agreement on the sundry civil bill as passed by the Senate.

The more important amendments agreed to by the House are: a rebate on tobacco, amounting to \$2,700,000; the conference added \$3,488,681 for the improvement of the White House amounts to \$47,445, while \$55,000 is added for the construction of a building to be devoted to offices for the White House force.

Among the appropriations for public buildings authorized by the omnibus bill are: Atlanta, Ga., \$75,000; Memphis, Tenn., \$25,000; Richmond, Va., \$75,000; New Orleans, La., \$200,000.

STILL ANOTHER DIVORCE SUIT. Mrs. Mollie D. Goodman Seeks Legal Separation--News of the Courts.

Mrs. Mollie D. Goodman, through her counsel, A. S. Lanier and Thomson & Minor, yesterday in the Law and Equity Court, instituted proceedings to secure a divorce from her husband, Wilmer P. Goodman. An injunction was awarded by Judge Minor restraining and enjoining the defendant from disposing of his property and ordering him to pay alimony to the complainant for her husband, and her child. Desertion and non-support are the grounds on which the separation is asked.

In the same court the same attorneys commenced a suit for Mrs. Lizzie W. Duke against her husband, Robert L. Duke, for the purpose of securing alimony. The complainant alleges that she has been abandoned by her husband, and desires the custody of the child.

The suit of P. M. Houston against Francis M. Shipman for \$500 for unpaid church dues, was heard in the Circuit Court. This case was removed from the Circuit Court of Henrico, and is being heard in the Law and Equity Court.

Hilton Venable (colored) was fined \$10 in the Hustings Court yesterday afternoon for an assault upon Tony Lewis, also colored.

Eugene Magnan, charged with assault, and Lewis Freeman, for petit larceny, appeal cases, were dismissed.
