Gypsies Charged With Barn-Burning in Fairfax. FAIRFAX, VA., January 12.—(Special.) The barn of Mr. George Watkins, residing near here, was totally destroyed Tuesday night by fire, including twenty head of cattle, two horses, and a large quantity of feed and farming implements. Oat straw, with which the loft was filled, was discovered scattered about the barn yard, and was traced to a gypsy camp a short distance away. There a wagon was found loaded with oat straw, some having been removed to a tent for bedding. A warrant has been issued, charging the gypsies with felony. John Small, William Small, and William Shelton were arrested Sunday. They were charged with receiving and burning the barn of George T. Watkins, but were released to-day. Mr. Watkins stated to the inquest at the preliminary hearing that he did not believe them guilty and requested their names be stricken from the list of those to be prosecuted.

RALEIGH, N. C., January 12.—(Special.)—In the House today a committee introduced a bill which relates to the question of building a proper station at Durham and other points in the State. Its language is: "To require when practicable in the judgment of the Corporation Commission, the laying of more railroads, which now or may hereafter enter any city, or town, or village, or hamlet, or any other place, to have a common or union passenger depot and to unite in the joint undertaking and expense of and maintaining such of such railroad, or such terms, regulations, provisions, and conditions as said commission shall prescribe."
