

ORDER TO RAZE A WHOLE BLOCK

Mayor of Portsmouth Condemns the Seaboard Buildings as Unsafe.

WOMAN'S SENSATIONAL SUITS

Man With Fourteen-Year-Old Wife Arrested for Bigamy.

(Special to The Times-Dispatch.) NORFOLK, VA., June 16.—Mayor J. Davis Reed, of Portsmouth, issued orders to-day requiring the owners of five buildings in the Seaboard block, Portsmouth's principal business center, to raze the structures because of their advanced and unsafe condition.

The Seaboard block stands on Crawford Street, adjoining the market, and has been condemned before, with the exception of the two buildings owned by T. J. Barlow, which were built on firm foundations with thick walls, and which have stood every official inspection.

Mayor Baird condemned the buildings now condemned by Mayor Reed. Efforts were made to repair them but the trouble was found with their foundations.

The condemned buildings are valued at \$5,000 each.

Winifred E. Horne, a young woman, said to be from Boston, has entered two suits in the Court of Law and Chancery against Thomas H. Hynor, of this city.

One is for \$100,000 damages on a contract, and the other asks damages in the sum of \$10,000.

The declaration has not been filed in either suit. The woman, it is said, in the \$100,000 suit will charge that she was induced by Hynor to come here from Boston to work for him in his brokerage office in the Atlantic building, and that through no fault of her own her employment was terminated.

The Portsmouth authorities, acting on telegraphic advice from Hamer, S. The man and girl were being held in the Portsmouth jail, pending further advices from South Carolina.

The telegram upon which Ingraham was taken into custody charges him with bigamy, forgery, larceny and the changing of his name.

Information received by the Portsmouth authorities is to the effect that Ingraham is the wife of a man and three children in South Carolina and married in that State the girl found here with him. The police report that Ingraham says his first wife will have a hard time proving that he was legally married to her.

The girl is being held in the part of the jail which is the home of the family of Deputy Sheriff Hoofnagle, who, with Detective Land, of Portsmouth, arrested the couple at 8 A. M. to-day, at a residence in Cottage Place on the suburbs, where they had been staying since their arrival here last Monday.






WELL-KNOWN RICHMONDERS WHO WERE CHOSEN GRAND OFFICERS OF ANCIENT ORDER OF DRUIDS


