CAR HIT BUGGY; JOYNES INJURED

Assistant Chief of Fire Department Will Be Confined to Room Several Weeks.

EDMUND C. STEDMAN DEAD

Well-Known New York Banker and Poet Dies Suddenly. NEW YORK, January 18.—Edmund Clarence Stedman, widely known as the "banker-poet," died to-night at his home in this city from a sudden attack of heart trouble.

Despite the efforts of physicians, the poet died two hours later, without regaining consciousness. Mr. Stedman had suffered recently with cardiac affection. Early to-day he began the preparation of a magazine article, and in the afternoon he was seen at luncheon. It was while returning to his study to resume work that the fatal attack came.

Mr. Stedman, who was seventy-five years of age, was born at Hartford, Conn., and while a student at Yale earned distinction in English and Greek composition. After a brief editorial experience in Norwich and Winsted, Conn., Mr. Stedman took up his residence in New York City, where he was connected with several of the daily papers and with Putnam's and Harper's Magazines.

He was a member of the Stock Exchange, retaining membership until 1906. Of late years Mr. Stedman had given his attention more to literary criticism.

BIG INFLOW OF CASH

Bank Statement Shows Increase of \$20,000,000 in New York. NEW YORK, Jan. 18.—A tremendous flow of cash from the banks throughout the country to the New York city banks was indicated to-day by the bank statement, which showed an increase of \$2,183,800 in the amount of cash held by the New York clearing-house institutions.

This increase in cash is not thought to be a permanent one, but it is believed to approach within a few millions of the largest increase ever recorded in a single week in this city. Financiers declared that it showed clearly that the interior banks were entirely reassured by the banks last week when for the first time since October a surplus of reserve was established in place of the deficit which had long existed.


