Mr. Page then took the floor and defended the ordinance as he had drawn it. He stated that regarding the satisfaction of property holders had been embodied in a statement made by Mr. Williams, he said that the Seaboard had at the previous meeting stated that not a tie would be laid of a spike driven into every property holder's back...

According to Mr. Page's construction of the ordinance as the company wished it passed, property-holders could only recover damages by resorting to the courts if the sums offered by the company were not satisfactory.
