Richard E. Van Byrd, of Winchester, who is named as United States District Attorney for the Western District of Virginia, is one of the best known men in public life in Virginia, and his appointment has been without opposition. Mr. Byrd was for three sessions Speaker of the House of Delegates, and did not offer for re-election to the House from the Frederick County district last year. While Speaker of the House he was patron of some of the most constructive pieces of legislation of that period. Mr. Byrd has law offices in Winchester and Richmond, and has been connected with a number of important legal cases. He has usually been allied with the organization or "machine" wing of the party. He was a classmate of President Wilson at the University of Virginia, and fought hard for his nomination both at the Norfolk State Convention and at the Baltimore Convention. Mr. Byrd was formerly Commonwealth's attorney for Frederick County. He was a member of the State Tax Commission and one of the prime movers in the movement for organization of the burden of taxation in Virginia, and has been several times mentioned as a possible candidate for Governor in 1917. He is a brother-in-law of Congressman W. C. Coker.

**South Richmond Man Wins.**  
John G. Saunders, of South Richmond, the new United States marshal for the Eastern District of Virginia, is at present deputy city sergeant in attendance on Hustings Court, Part II. He was formerly City Sergeant of the city of Manchester, and was continued in office under the terms of the annexation agreement.  
R. C. L. Moore, of Stafford County, named as collector of internal revenue for the Eastern District of Virginia, has been a member of the state Senate for the last four years. The Thirtieth Senatorial District is composed of Spotsylvania, Stafford, Louisa and the city of Fredericksburg.  
John M. Hart, of Henrico, named as collector for the Western District of Virginia, has been eight years in the state Senate. He was highly indorsed for the position by Congressman Carter, and it has been understood that his nomination was opposed by Senator Swanson. The Senatorial District is composed of Henrico and Montgomery Counties, and the cities of Henrico and Bedford.  
Norman R. Hamilton, of Norfolk, named as collector of customs of Norfolk, has been for years a member of the staff of the Norfolk Leader-Dispatch, and is said to have had strong endorsements for the position.


