REMARKS OF MR. BYNUM, OF NORTH CAROLINA.

In the House of Representatives, Jan. 13.

The House being in Committee of the Whole upon the Naval Appropriation Bill—

Mr. Cabell moved to amend the sum of \$950,000 to be repaid and wear and tear of vessels in commission, and insert, in lieu thereof, the sum of \$2,000,000 for the same objects.

Mr. C. said he was instructed to move this amendment by the Committee of Ways and Means, with one single exception; but, in saying this, he begged also to observe, without reference to the question of war, that he was not to assume the responsibility of our relations with Mexico and with France as a reason for requiring this additional appropriation for the Navy.

Mr. Thompson of South Carolina spoke with much violence and bitterness against the appropriation, against the President, against the Administration, abusive of Mr. Rice, the negotiator of the French treaty—whom he likened unto a Jew, asking 70 cents, then falling to 25 per yard for his calico—as also unto a horse-jockey, who hoasts of cheating at cards in a house-docky, who charged our government with being the aggressor, enlarded the forbearance and conduct of France—and was but little behind Mr. Calhoun in his Anti-American sentiments.
